#### **RSN-SPARSE**

I have just heard that I have been confirmed as the WNC Lead representative on the Rural Services Network (RSN) previously known as SPARSE. I will be ably supported by, Councillor Alan Chantler, ward member for Braunston and Crick. The Rural Services Network is a Special Interest Group of the Local Government Association. It is a membership organisation and works on behalf of its members as the national champion for rural services.

## The Queen's Green Canopy Initiative-Celebrate 70 years of Service

WNC is supporting the initiative and are encouraging town and parish councils to plant trees. Schools, community groups and clubs are invited to apply for free saplings from The Woodland Trust for planting from October 2021 to March.2022. #### **SEGRO**

I wrote to SEGRO again regarding Grange Park Parish Council's request to be included in their Community Fund Scheme. Grange Park Council was advised that residents of Grange Park were experiencing relatively few or limited negative impacts from SEGRO and that they are a major beneficiary of the investment into the enhancement to M1 J15 which will hugely improve local traffic flows and journey times. Therefore, they were not considered eligible for a grant. I fail to understand why Grange Park should have been treated differently to the other local communities. Grange Park Council believe that they should have been included in the Community Fund Scheme at the outset. I had chased Gary Gaskarth, cc Andrew Pilsworth, MD, National Logistics. My email was passed to Kate Bedson, Senior Director who wrote to me on the 20<sup>th</sup> July. I have responded to Kate's request for a meeting as follows:

"Thank you for your email of the 20th July 2021 in response to my second e-mail to Gary Gaskarth. I am pleased to hear that there is some discretionary funding for local community projects that you can administer on an annual basis, but disappointed that you cannot revisit the initial Community Fund Initiative for Grange Park Council, which is at the heart of the present line of enquiry. I would be happy to meet with you and for you to introduce me to your colleagues Ian Rigby and Neil Impiazzi, so that we can discuss funding for Grange Park Community Projects and I can better understand SEGRO's position." I have offered a number of dates and I will let you know more when I receive an update. (26 or the 30 July; or the following week on 2 or 6 August).

## **Foxfield Country Park Gym Equipment**

I promised that I would go and sample the outdoor gym equipment placed in 6 specific locations around Foxfield Country Park. I went there on Wednesday 23rd June 2021.

## **Grange Park Café Bar 9 July**

I had arranged to meet Councillor Julie Bainbridge, Grange Park Council at the Café Bar in Grange Park in order to find out about her Bertie Bottle campaign and their regular litter picks around Grange Park. It was timely as it coincided with a request for a meeting with the Clerk, Tracy Sampson and Councillor Mike Aluko to help progress their discussions with SEGRO. We were able to discuss at length a number of Grange Park related matters including SEGRO and I have agreed to help achieve progress on their Community Fund application. We also spoke about the Summer Fest, which is being held on the 4th September from 1.00pm-8.00pm at Foxfield Country Park. They extended an invitation to all three of their WNC Councillors. I was delighted to accept and agreed to help on the day.

#### **GRANGE PARK Litter and Bus Stops**

The Grange Park Parish Council have been asked by the community whether it is possible to move bus stops and if so how best to achieve this. The reason that this question has been raised is because the residents of Grange Park would like to make the local companies accept some responsibility for their staff littering the environment as they arrive and depart from their place of work, and create a better entrance to the estate. I have referred the matter to Highways and Waste for action. Thank you for your email on the issues being experienced a Grange Park. On 20 July, I received the following response from James Loader, Bus and Rail Department. "The main suggestion of seeking to have buses stopping within the confines of the warehouses does, as a first impression at least, feel problematic and will need some consideration. Some of the issues I can immediately think of are finding somewhere safe for a bus to turn in forward gear and for passengers to safely wait, the reliability issues it may cause if buses start getting blocked in by vans/lorries and that around 50% of buses on this route come from Milton Keynes and are therefore primarily aimed at other users for most of the day. The existing stops would also need to remain in use for non-warehouse passengers. Notwithstanding the above, I do have a weekly (except this week due to annual leave, typically) conference with Stagecoach and will take the opportunity to talk this through with them and come back to you. I would also agree that a level of ownership from the employers is also required to bring about a solution." I will let you have an update when I hear more.

#### Hackleton

## **School Minor Works Budget 2021/22**

On the 20th June the Cabinet approved the 2021/22 'School Minor Works' budget. The WNC allocation was £1,629,546 'School Condition Allocation' funding for 2021/22. This would be utilised as WNC's 'School Minor Works' budget for 2021/22.

## **Enhanced Partnership and Bus Improvement Plan**

By the end of the October 2021, the Council will form an Enhanced Partnership and publish a local Bus Service Improvement Plan, detailing how we propose to use our powers to improve services. Government expects actual delivery of Enhanced Partnerships by April 2022. From that date, the new discretionary forms of bus funding from Government will only be available to services operated, or measures taken, under an Enhanced Partnership or where a franchising scheme has been made. The Department for Transport expect that the Bus Service Improvement Plan will be reflected in the Local Transport Plan, and this is likely to require an update of at least the Bus Strategy, which forms part of the Local Transport Plan.

#### **North West Relief Road**

The Cabinet has agreed to progress a bid for £20 million of Government funding for Northampton's North-West Relief Road. The Levelling Up Fund is a £4.8 billion government programme to support investment in infrastructure, such as local transport projects.
