NEWS REPORT APRIL 2022

Monthly Highlights

WNC raised Ukrainian flags at our civic buildings in Daventry, Northampton and Towcester in solidarity with the country's people. We continue to send a message of support to the people of Ukraine, for the horrific situation they find themselves in. They have our sympathy and our support, but they also have our huge admiration for the brave way they are pulling together in the face of adversity. WNC will be provided with £10,500 per person relocated to our area, from which we will be required to cover a wide range of essential support including:

- Assessing host properties
- Carrying out Disclosure and Barring Service (DBS) checks on hosts enhanced checks will be required for homes which will be hosting children or vulnerable adults
- Providing immediate financial assistance, potentially until access to benefits and work entitlement is arranged
- Continuing to support the household over the first 12 months and help with access to services and integration into UK systems and processes.

I have included other information in my report about the Government's Homes for Ukraine sponsorship scheme

On 15 March 2022, a group of volunteers in Castle Ashby launched a new community larder. They have been looking at a way to get affordable sustainable food to the villages and saving waste, by building on the work that they did during lockdown for the community. I was pleased to see the new Community Larder at the Compton Club, Castle Ashby in action and I was impressed by the local interest and the work of the volunteers. TowFood Community Larder offers different categories of membership, and it is a community larder network that partners with local supermarkets, businesses and food surplus providers to reduce food waste and distribute affordable food throughout the community. They welcome everyone, with their main ethos being to reduce food waste. I had intended to visit the Denton Community Larder at St Margaret's Church the following week, but unfortunately, I was diagnosed COVID positive, and I was out of action for two weeks.

For those of you that gave your views and ideas on how we shape services and support communities to help West Northants thrive, here is what to expect next. We will analyse the resident's conversation and draw out the themes that we heard from our residents. We will share these with staff in a second big conversation for council colleagues to consider along with offering an opportunity for them to shape how the council is working. This conversation for staff will be live from 4 to 22 of April. Then WNC will consider everything that has been contributed in the big conversations to create neighbourhood strategies, a citizens charter between the council and residents, and set out the council's ways of working for staff.

I promised to let you have an update regarding the recent speed limit review panel meeting. They considered Denton Parish Council's request for a 40mph limit between to the two access points into the village on the A428. There was a lot of discussion surrounding the request and it was decided that it would be useful for Police colleagues to gather some up-to-date speed data on the sections of road in question. This will enable the panel to make a more informed decision. The request will be considered further at the next meeting when the speed data will be available. In my monthly report, I have included an update on the Red Route process along the A428 between Great Houghton and Yardley Hastings.

I will keep you informed.

I received eleven expressions of interest and seven completed applications with seven awards issued for my Covid Support Fund. One application didn't meet the criteria, three weren't progressed and one project was funded jointly. I have allocated my entire £2,500 available fund. Councillors Andrew Grant and Fiona Cole may still have some funding available. I have set out in my monthly report, a complete list of projects, supported by me.

We will be providing those most in need with immediate financial help in the form of vouchers that can be redeemed against shopping costs in a range of supermarkets. With the recent and ongoing rises in the cost of living, it is often the most vulnerable and disadvantaged that have the hardest choices to make, sometimes as stark as "heating" or "eating." Using a grant provided by the Department for Work and Pensions (DWP), West Northants Council will be providing a one-off payment in the form of vouchers. All previous recipients of the Household Support Fund fuel voucher scheme, which has operated from December 2021 will receive a payment of up to £80. All house owner/renter recipients of the Council Tax Reduction Scheme (CTR), both working and non- working and including pensioners will receive a voucher payment of £50. The vouchers can be redeemed against shopping costs at a range of supermarkets but must be redeemed by 30th April 2022. All eligible recipients will start to receive a notification together with the voucher(s) from 30th March.

The community business movement is growing, with the number of community businesses increasing by 3% in 2021, resulting in 840 businesses trading across the UK. To support the 27 businesses opening in 2021, 6,300 people raised around £3.4m in community shares. Read more about the Plunkett Foundation Impact Report in monthly report.

Applications for SEGRO funding are made using a proforma, which is reviewed by the WNC S106 team to confirm it is in accordance with the terms of the agreement and it is then circulated to the Community Liaison Group for comments. The proforma and comments will then be forwarded with a recommendation for consideration by WNC. If authorised, the funds are then paid out. The applicant and the Community Liaison Group will be advised of the outcome of the application for funding. All that remains is for Grange Park Parish Council to apply for the funds for an eligible project.

Councillor Fiona Cole has called in the Planning Application WNS/2022/0154/FUL, the Runway West of Forest Road, Piddington for consideration. It relates to a change of use from Agricultural to grass runway with associated facilities for use as a microlight airfield (retrospective).

I have enclosed a copy of the WNC letter confirming the above Article 4 direction relating to the removal of permitted development rights for means of enclosure (gates, fences, walls etc) relating to the above land. I have also attached a copy of the Direction and associated plan, which remains unchanged, but will now continue to have effect unless the local planning authority make a subsequent direction or cancel the Direction.

We are encouraging residents and businesses to make personal pledges on how they will do their bit to make West Northants a more sustainable place to live and work. Last week saw the launch of Sustainable West Northants – an ambitious new approach towards protecting and improving the local environment, economy and society for future generations.

The Market Square survey opened Thursday 31 March and will run until the end of April, and team representatives will be in the town centre with a street survey from Thursday 7 to Saturday 9 April. There

will also be a display at the Grosvenor Shopping centre from 7 April to 4 May outlining the latest plans for how Market Square will look once redevelopment completes in 2024. https://www.bigconversation.co.uk/northampton/

West Northamptonshire Council's Cabinet is set to consider whether to adopt a draft Anti-Poverty Strategy at its meeting on 12 April 2022. The strategy, which will be considered by members is designed to tackle poverty and deprivation and is particularly important in the context of current financial pressures facing households. It would also form part of the council's bold new approach to improve social, environmental and economic sustainability, which will help protect communities for future generations. The WNC approach is summed up in three overarching priorities, which are in turn built on some key principles aimed at helping people to live the best life possible. The strategy identified has ten underlying principles, which are set out in my report.

In February I started Community Walkabouts. The first was in Brafield and it was most beneficial as it helped me to discuss with the community and councillors the work that needs to be done to ensure that we have a safe and pleasant environment for those who live there. West Northamptonshire has a rich legacy of rural villages with communities that need our support and encouragement to continue to thrive and be socially and economically viable. I intend to complete a similar exercise in the other parishes. Please let me know when you would like to organise a session in your area. Grange Park and Quinton have asked me for a Community Walkabout, and I am just awaiting confirmation of suitable dates.

It's been a difficult month as my wife, and I were both diagnosed Covid positive on 18 March 2022. Having escaped it for 2 years and both being 'triple jabbed', we were somewhat surprised by it all. However, it was challenging for at least a week when we experienced all the known key symptoms including a ferocious sore throat. Recovery from COVID-19 is defined as an absence of fever, with no use of fever-reducing medication, for three full days; improvement in other symptoms, such as coughing and shortness of breath; a period of seven full days since symptoms first appeared. Then, two negative swab tests on consecutive days are considered as the all-clear – meaning self-isolation can end and a patient can theoretically begin having contact with others, including returning to work. In our case this took two weeks altogether.

I was unable to attend the Day of Remembrance and Reflection Memorial Service on 17 March as I was unwell. It was an opportunity for all of us to come together to pay our respects to the colleagues we lost to the pandemic and to thank all social care workers in our county for their continued work. My thoughts are with those families who have suffered so much during this pandemic.

Request for A428 Speed Restriction, Denton

I promised to let you have an update regarding the recent speed limit review panel meeting. They considered Denton Parish Council's request for a 40mph limit between to the two access points into the







village on the A428. There was a lot of discussion surrounding the request and it was decided that it would be useful for Police colleagues to gather some up-to-date speed data on the sections of road in question. This will enable the panel to make a more informed decision. The request will be considered further at the next meeting when the speed data will be available.

In addition, I can advise that as part of the Red Route' process some route hygiene works have been identified along the A428 between Great Houghton and Yardley Hastings. This includes undertaking works to clean/repair/upgrade/replace existing signage to improve conspicuity of

hazards, including junctions, village entrances and lay-bys, to ensure a consistent approach to hazard signing between the two villages. Consideration was also given to improving the signage at the lay-bys and changing the alignment of the western lay-by to prevent right turns and provide an acceleration lane. This work was all approved and will go into the programme subject to prioritisation. 


The Denton Village Surgery prescription collection service



EVENTS IN UKRAINE



Homes for Ukraine Sponsorship Scheme

This allows people in the UK to offer a home to people fleeing the war. Once refugees have been matched with host families, they can begin the visa application process. The Government is carrying out the visa checks and once these are cleared, applicants will be given leave to travel to the UK.

The Government's Ukraine Family Scheme

A family visa scheme, administered by the Government, is also in place. This allows people who were living in Ukraine on or before 1 January this year to apply to join UK-based family members. More information can be found on the Government website

Our Council's role in the local response:

WNC will be provided with £10,500 per person relocated to our area, from which we will be required to cover a wide range of essential support including:

- Assessing host properties
- Carrying out Disclosure and Barring Service (DBS) checks on hosts enhanced checks will be required for homes which will be hosting children or vulnerable adults
- Providing immediate financial assistance, potentially until access to benefits and work entitlement is arranged
- Continuing to support the household over the first 12 months and help with access to services and integration into UK systems and processes.

We are working closely with our partners, drawing on the invaluable experience we gained during the Afghan resettlement programme, to ensure we meet the needs of these arrivals. We have opened lines of communication with sponsors in our area so we can build on our understanding of the responsibilities we have towards Ukrainians arriving in West Northants, and to prioritise the accommodation and safeguarding checks we need to make. A team is being trained and mobilised to undertake the pre-arrival accommodation checks and facilitate the DBS applications, and we are also in the process of recruiting a new team of resettlement support officers to work with Ukrainians and deliver the support that they need over the next 12 months. There are many ways people and local organisation can help with the resettlement process, from providing support within the community to donating specific items.

- To be accepted and valued simply for who they are.

In order to provide these opportunities for people, it will be necessary for the council to work with a range of partners. The three governing principles behind this approach are:

- Supporting people who are struggling in poverty now
- Preventing people falling into poverty in the first place
- Influencing the Government and other national organisations to get the best deal for the people of West Northamptonshire.

The strategy has been developed with cross-party support and its aims include improving health and wellbeing, increasing average household income, reducing reliance on benefits, lowering the cost of rented and social housing, improving outcomes for young people and tackling fuel poverty. 




West Northamptonshire Strategic Plan, Spatial Options Consultation

West Northamptonshire Council is preparing a new strategic plan, which will guide development for the area up to 2050. The West Northamptonshire Strategic Plan (WNSP) sets out a vision for West Northamptonshire in 2050 and the objectives to realise the ambitions for our economy, our communities and our environment. The next Planning Policy Meeting is on 26 April 2022.

Article 4 Direction, Land off Horton Road, Hackleton

WNC received an EIA Scoping Opinion submission on 8 February from the applicant Manor Oak Homes for 900 dwellings on land south and east of Grange Park and WNC issued its Scoping Opinion by the agreed timescale.

ENVIRONMENT

Warning over unlicensed waste carriers

A woman who paid someone £70 to take her old fridge away has been ordered to pay more than £2,000 in fines and court costs after it was fly tipped. Neighbourhood Wardens from West Northamptonshire Council traced the fridge, together with several other household items, back to Farhiya Amir after they were found dumped in shrubbery near her home in Melbury Lane, Northampton last May. Miss Amir (34)





admitted she had paid two boys £70 to take the rubbish away and was issued with a £400 fixed penalty notice. But after ignoring the notice she was brought before Wellingborough Magistrates last Tuesday, where she pleaded guilty to failing to comply with the domestic waste duty of care requirements and was fined £400 and ordered to pay court costs of £1,700 plus a £40 victim surcharge. Under the duty of care, anyone paying

someone to dispose of waste must ensure they use a reputable business with a waste carriers' licence and documentation to prove it. We're doing all we can to target fly-tippers, however residents can play a role in this too, by ensuring they only use licensed, responsible operators to take away their rubbish. Please be on your guard against unlicensed waste operators offering to take away unwanted items on the cheap. If it sounds too good to be true, it's likely they are not paying for the waste to be properly disposed of and will simply dump it instead. Do not be left paying the price. Please protect yourself by making sure that anyone you pay to take your rubbish away is properly licensed to do so. Also fined by the Court last Tuesday was Lola Declemente (21) of Broughton Place in Eastfield, Northampton, who was found guilty in her absence of littering and fined £250 and ordered to pay £1,300 in legal costs plus a £34 victim surcharge.

Great British Spring Clean

Litter picking kits, which include litter pickers, sacks and bag hoops are available to borrow from our Council, along with a step-by-step guide to help plan a safe, effective and well-supported event. Community litter picks have already got underway in Daventry, with residents and volunteers from the Town Council and the Tesco staff team cleaning up the Grange Estate and the town centre on Saturday 26 March.

BID has organised a tidy day on Monday, 4 April, when business owners will team up with volunteers and the Mayor of Northampton, to help clean up the town centre. Community Businesses

The Plunkett Foundation's 2021 Impact Report reveals that the number of community businesses has continued to rise, despite the disruption of the pandemic. The report also shows that more people than ever before are now interested in setting up a community business, with over 300 communities across the UK getting in touch with Plunkett for start-up support last year.



The community business movement is growing, with the number of community businesses increasing by 3% in 2021, resulting in 840 businesses trading across the UK. To support the 27 businesses opening in 2021, 6,300 people raised around £3.4m in community shares.

Public interest and support for community ownership is also growing, evident in the number of community businesses featured in the national press, as well the 18% increase in Plunkett's membership. The sharp increase that we saw in 2020 in enquiries about setting up a new community business was maintained in 2021, with 26% more groups looking to start a new project in 2021 compared to 2019 prior to the pandemic.

NHS Dental Services in Northamptonshire

I am receiving complaints about the lack of NHS Dental Services in Northamptonshire. It is made worse by the fact that residents are unable to understand the current position as the various search engines do not have the most up to date information about which Dentists are currently taking on NHS Patients. In fact, in a recent BBC investigation dated 7 February 2022, entitled

Northamptonshire: Finding an NHS dentist 'a needle in a haystack' - BBC News they found only one dental practice in the county taking on NHS patients.

The Northamptonshire CCG NHS Dentists website suggests that there were 8 Urgent Dental Care Services in Northamptonshire, without stating their location. Indeed, when you search on 'Find a Dentist', they mostly state 'This dentist is not taking any new NHS patients now' or something similar.

I am asking how the Northamptonshire CCG intends to address the provision of NHS Dental Services in Northamptonshire. I have been advised that all primary care concerns and complaints come under the remit of NHS England/Improvement, and I have been referred to england.contactus@nhs.net.

I anticipate that rising energy costs will severely impact the cost of living and NHS Dental Services will be much needed this year.

School Admissions Arrangements

The school's admission authority determines school admission arrangements annually, even if they have not changed from the previous year. We are the admission authority for all community and voluntary



controlled schools in the area. Other types of schools have their own admission authority:

- The governing body is the admission authority for foundation and voluntary aided schools
- The academy trust is the admission authority for academies, free school and UTCs

Admission authorities of schools wishing to make changes to their admission arrangements must publicly consult on the changes before determination. Further information can be found on https://www.westnorthants.gov.uk/school-admissions/school-admission-arrangements

Allocation of Secondary School Places

A total of 4,786 secondary school places have been allocated to pupils across West Northamptonshire today. This is the first year that places have been allocated specifically within West Northants, following on from local government reorganisation last year. 79.4 per cent of applicants – 3,798 children – have been allocated a place at their first preference – a slightly lower percentage than for the county last year (80.7 per cent in 2021). 95.8 per cent of applicants have been allocated one of their preferred schools – like the number of children getting a place at a preference school (95.7 per cent in 2021). 98.7 per cent of applications were made online (the same as in 2021).



Families who applied for their secondary school place online and within the deadline are able to check their offer on the council's website today at – www.westnorthants.gov.uk/secondary-school-offers. Any parent has the right to appeal (through the independent appeals process) against refusal of a place at any school for which they have applied. The next round of secondary school place allocations (for late applicants) will take place in April.

Primary school allocations will be announced on April 19, 2022.



Northampton Market Square

We are inviting people to give their views on what events and other features Northampton Market Square should host following its redevelopment. A key part of the project is to help create a large public space, which can be used for a variety of purposes, and we would like to hear what people want to see there. It could be anything from musical or theatrical events to big screens for major sports fixtures, plus individual ideas. addition to the existing market stalls,



we would like to hear what features would bring visitors into the town centre, such as specialist markets and wide-ranging leisure activities. Reporting Highway Problems

Report and track highway problems via Street Doctor Before you start

Some problems cannot be reported through Street Doctor because they are the responsibility of other organisations. Please check first whether the problem you wish to report is listed below:

- Abandoned vehicles
- Flooding
- Speeding
- Trunk roads (e.g. M1, A5, A14, A43, A45)
- Street lighting
- E-Scooters

Report or track a problem using Street Doctor

Any highway related issues or defects should be reported via Street Doctor, the Local Authorities public reporting system. By using Street Doctor, your report will be logged appropriately, go to the



right team and you will, receive updates of what we are going to do and why. Issues reported will be looked at initially within 5 working days to determine what further action may be required. Please do not try to report issues and defects via Twitter or on any other social media channels. Some lesser-known issues you can report using Street Doctor are:

Rights of way e.g. gates, livestock, stile

Winter maintenance e.g. grit bins, gritting, snow

You can tell us about most problems on the roads or highways (apart from those listed above) - or you can track a problem you have already logged.

New on-street vehicle charging bays

Parking restrictions and enforcement are being introduced at the new on-street electric vehicle charging bays in West Northants to ensure they are available for people to use them.

In January 2022, on-street electric vehicle charging points were installed at seven locations across Northampton as part of the council's partnership with the Virgin Park and Charge (VPACH2) project.

Each location has four parking bays. To minimise the impact on parking availability in the short term, two bays are for electric vehicles only while two bays can accommodate either electric or non-electric vehicles. The enforcement will be for the electric only bays — marked 'Electric Vehicles Only' - and will start on April 8 at:


- St James' Park Road NN5 5EL
- Upper Thrift Street NN1 5HR
- Ardington Road NN1 5NE
- Barry Road NN1 5HU
- Oakwood Rd NN1 4SX
- Semilong Road NN2 6BU
- Vicarage Road NN5 7AX

To give residents time to adjust to the new parking arrangements, drivers who flout the parking restrictions during the first two weeks following enforcement will be issued with warning notices, rather than a fine.



Northampton North West Relief Road

This week marks the beginning of work to create the Northampton North-West Relief Road (NNWRR). Once complete, the project will link the A428 Harlestone Road to the A5199 Welford Road. The scheme is supported by SEMLEP, the South East Midlands Local Enterprise Partnership and benefits from £7.93 million of Local Growth funding. The first section of the relief road has already been constructed as part of the Harlestone Manor development, while the developers of the Dallington Grange housing estate will construct the second section to Grange Farm, just south of the railway line. West Northamptonshire Council is responsible for building the final section across the railway line to the Welford Road.



A layout of the North-West Relief Road.


The North-West Relief Road, a Northamptonshire County Council

Early works starting will include a site compound being set up off Sandy Lane at the Northern end of the scheme, utility works, preparation of access routes, archaeological excavations and environmental surveys. The construction of the NNWRR will follow. The majority of this initial work will take place offhighway and impacts on road users are expected to be minimal. This road is only part of the infrastructure required to facilitate development to the north of Northampton, with the Northern Orbital Road, priority of West Northamptonshire Council, being the most important. Motorists passing the site will see some activity starting to take place as initial work begins but it will not significantly affect their journey. The

Design and Build contractor Balfour Beatty has been appointed, with works expected to complete in spring 2024. 
A diversion will be in place at all times as shown on the map below. The red line shows the road closure and the blue line shows the diversion.

What we are doing/the benefits – Surface Dressing is a cost effective road surface treatment used to prolong the life of roads that are starting to show the first signs of minor deterioration. It extends the life of the road surface, increases skid resistance and seals the surface to stop water ingress, protecting it from damage caused by severe winter weather, such as

potholes. Prior to surface dressing, carriageway patching will be undertaken to address any minor issues to prepare the road for the dressing which will take place in the summer.

Surfacing Work Bedford Road, Denton

Northamptonshire Highways are starting to undertake their surface-dressing programme of works. As part of these works, there will be surfacing works taking place on the Bedford Road in Denton. To undertake the works safely will require that the road is closed for a period of up to 5 days from the 20th April 2022 at off peak times. Northamptonshire Police-Update on Quinton Incident

A successful demolition of 62 items of WW2 ordnance took place at roughly 12.30pm 30 March 2022 in School Lane, Quinton.
