# **NEWS REPORT MARCH 2023**

# **Monthly Highlights**

Due to more visa applications being approved, further hosts are needed as new arrivals from Ukraine are looking to make West Northamptonshire their temporary home.

Many of you have written to me expressing your concerns about the numbers of accidents, some fatal that have taken place over the years on the A428 through Northamptonshire. Over the last two years, I have worked on the need to reduce the speed limit on the A428 from Brackmills to Yardley Hastings. The first hurdle was to provide evidence and then convince members of the Road Safety Panel of the need for a change to the speed limit on this stretch of road. Agreement was reached last year, and I was advised of the Council's intention to reduce the speed limit between The Lakes Roundabout, Northampton & the West Northamptonshire Boundary. On 2 March 2023, WNC finally wrote to several interested parties informing them of proposals to introduce a 40mph speed limit Order on Bedford Road, Northampton and a 50mph speed limit on A428 Northampton Road, through Great Houghton, Little Houghton, Brafield on the Green, Denton, Castle Ashby, and Yardley Hastings. The existing 30 mph stretches through Brafield on the Green and Yardley Hastings remain unchanged. The proposals have been put forward for maintaining safety and have been agreed through the Speed Limit Review Panel. If there are no objections by 23 March 2023 then the Highway Authority will proceed to the next stage of advertising the public notice.

Thank you to all those residents who provided evidence of the need to make these changes and supported me with this campaign from the outset.

On the 15 February I meet with Councillor Phil Larratt to seek further clarity from West Northamptonshire Council regarding Concessionary Fare reimbursement. Britannia intends to run a service on the Yardley Hastings, Denton, Brafield on the Green, Little Houghton, and Great Houghton route along the A428 affected by the 41-bus service. I have asked whether WNC as a TCA has at any time offered a discretionary concessionary travel schemes, i.e., schemes which go beyond the statutory minimum in one or more respects under the provisions of the Transport Act 1985 for this route. I have also asked about the reimbursement figures for this route from the former Northamptonshire Council and now West Northamptonshire Council as a Unitary over the past two-three years and how it was calculated?

I had a further meeting on 7 March to take this conversation further. My concern is that if this route is unviable, then how do we build a plan to overcome this problem? To make this route viable for a rural community transport provider then the villages affected together with WNC must have a better understanding of what needs to be done to make the route sustainable and how best to encourage take up. This is still work in progress and we plan to continue this conversation with another Concessionary Travel Reimbursement expert. I will provide you with a further update in due course.

Following an enquiry from Hartwell Parish Council, I met with Councillor Phil Larratt on 15 February 2023 to discuss the ongoing provision of the 33/33A Bus service. Whilst it is impossible to guarantee the future of the service on more than a year-to-year basis, Phil said in response to my question about the 23/24 service provision: "Yes it will continue until we decide otherwise, depending on the SCP report into the provision of Rural Transport." "This report is looking into how much to invest into Community Transport, Demand Responsive Transport and other Operators." I will keep you appraised of any future developments.

Kier have been working exceptionally hard on the Hartwell Flooding and blocked drains and the matter is almost resolved. WNC identified a blockage in the main drain on Ashton Road near to the Oak Leaf Group

building. The drains were overgrown with tree roots, which they believed to be the main cause of the drainage issues in the area. They have removed the tree roots with specialist equipment. But WNC is aware that there are some further tree roots which require removal, and these are being programmed. The residents are still concerned about the drains on the corner of Amberley Way and higher up Blacksmith's Way, and I have passed this information over to Kier for further action. I will keep the residents informed.

SEGRO sought a change to the Northampton Gateway Rail Freight Interchange Development Consent Order 2019. The Application was published on 10 August 2022 and the Secretary of State initiated a consultation on the Application on the same day. The deadline for representations on the Application was 26 September 2022. The 1,094 representations submitted in response to the consultation were published on 11 November 2022. The Secretary of State then invited comments from any Interested Party on the representations received. The Secretary of State published a submission from the Applicant dated January 2023 which set out their response to the representations on the Application. The Secretary of State also invited any Interested Party to respond to any of the points raised in this submission. The new deadline was 15 February 2023. All responses were published on 24 February 2023. The outcome is still awaited.

I met with Aileen Evans, CEO and Phil Hardy, Executive Director Operations, Grand Union Housing Group on 2 February 2023 to discuss my GUHG case work and agree a number of actions. I was able to resolve most of the issues which were outstanding but there is still further work needed on answering residents' queries and the long-term solution for Lodge Road/Close, Little Houghton.

On 7 March 2023, the Local Government Boundary Commission for England (LGBCE) launched a public consultation on the proposed map and councillor numbers, following the first stage consultation which took place in autumn 2022 where residents gave their views. The consultation on the outline areas will run until 15 May and people can get involved by giving their views on the LGBCE's website where they will also find useful guidance and maps of the current wards.

I have attended several community events this month, which has given me lots of opportunities to catch up with so many of you. Please read about them all in my Monthly Report.

On Wednesday, 22 February, members approved the final budget proposals, Housing Revenue Account and setting of the Council Tax for 2023/24. In common with local authorities across the country, the Council is facing severe financial pressures due to factors including the current economic climate, high inflation rates driving up running costs and an increase in demand for services, particularly around supporting children in care and vulnerable adults.

Despite these pressures, the Council has worked hard to balance the books and has set a balanced revenue budget for 2023/24 of £383.5m (excluding grant funded schools spending of £443.7m).

The budget includes a Council Tax increase of 4.99%, well below current inflation rates and in line with the Government's allowance, crucially generating extra funding of around £12m – with 2% of the increase going towards funding adult social care. This represents an average increase on a Band D property of £80.50 a year, the equivalent of £1.55 a week.

WNC is consulting on Proposed Active Travel Improvements around Abington Park, Northampton.

There is a new deadline for the Private Hire and Hackney Carriage Licencing Policy Consultation. The 26 March deadline for this consultation is extended to Sunday 23 April to allow people more time to fully review it and consider their views

West Northants Council manages over 190 parks and open spaces, the majority being situated within Northampton Town. There is a feedback survey about twenty-two of these parks. We would like to hear about the park you visit the most. The information you provide will help us to improve our parks and open spaces and to prioritise work plans. Your responses are completely anonymous. The Consultation runs until 31 March 2023.

West Northamptonshire Council is looking for feedback on proposals to transform Chalk Lane Car Park in Marefair, Northampton into a Heritage Park. This will offer open green space for families and the local community to enjoy while celebrating the heritage of the area. People are invited to review the plans and have their say on the online consultation, which runs until Friday, 7 April.

WNC Trading Standards Team is encouraging everyone to register all appliances in their home - whether they are new, old, or second-hand. That way, you never miss a safety notice & recall. It is a free and easy way to improve safety in your home.

If you would like to organise a street party with friends and neighbours over the Coronation weekend, you will need to apply to hold a street party and apply for a temporary road closure. Applications should be made by Monday 27 March 2023. There is no charge for Coronation commemoration road closures from 6 to 8 May 2023.

WNC has a new Cost-of-Living Online Support Hub. This together with our customer services team is there to help our residents access information and advice about the rising cost of living and find the support that is available to them. Please access advice and information, including a directory of warm spaces, on our Cost-of-Living Online Support Hub. All the various links are in my Monthly Report. For those who cannot access the Internet then please call WNC's customer services team and speak to somebody directly about the support available between the hours of 9am to 5pm, Monday to Friday. Please call us on 0300 126 7000.

The Department for Levelling Up, Housing & Communities (DLUHC) proposed an increase in planning application fees in a new consultation, which opened on 28 February 2023. The consultation said the government has received "consistent feedback from all sectors" that due to an "absence of adequate resources and capability" the planning application service is not "consistently performing at the level it should."

At the Planning Policy Meeting on 28 February, the WNC response to the Government's consultation document on proposed reforms to national planning policy was agreed.

DLUHC is therefore proposing to raise planning application fees by 35% for major applications and 25% for all other applications. This means that for non-major developments the fee will go up from £462 to £578 and for major developments it will go up from £462 to £624. The proposed rise in fees would apply to all applicants unless they are eligible for existing exemptions. The consultation opened on 28 February and will run for eight weeks until 25 April.

People living in rural areas are being urged to complete a survey on the cost of living. The Rural Services Network (RSN), in partnership with the Citizens Advice Rural Issues Group, has launched the Rural Cost of Living Household Survey to understand more about rural household budgets during what is a very difficult time for many. The survey closes on 31 March 2023.

Check out the school term dates and holiday dates for 2023 in my Monthly Report.

People are being encouraged to make sure they put the right stuff in their recycling bins in a bid to reduce contamination and significant disposal costs. If recycling is not handled correctly then it can lead to whole loads being rejected and set for disposal, costing on average more than £30,000 each month.

Residents across West Northamptonshire can now sign up to receive optional, chargeable garden waste collections from April 2023. The annual subscription charge for the fortnightly service from April 2023 to the end of March 2024 is £55 per bin and people can subscribe via the link on our website.

A total of 4,784 secondary school places were allocated to pupils across West Northamptonshire on 1 March 2023. The next round of secondary school place allocations (for late applicants) will take place in April / May. Primary school allocations will be announced on 17 April.

I thought you might like to hear about a small grants scheme available through the Foyle Foundation. I get requests from community interest groups and Parish Councils for grant funding, and I was pleased to hear last week that one of the suggestions that I had made had resulted in a Community Group acquiring £5k grant funding from a little-known company-The Foyle Foundation.

A new energy scheme for businesses, charities, and the public sector was confirmed, ahead of the current scheme ending in March. The new scheme will mean all eligible UK businesses and other non-domestic energy users will receive a discount on high energy bills until 31 March 2024. This will help businesses locked into contracts signed before recent substantial falls in the wholesale price manage their costs and provide others with reassurance against the risk of prices rising again.

The £2 cap on bus fares in England has been extended for three months following warnings that hundreds of services could be cut if it ended. It had been due to expire on 31 March but has been extended until the end of June.





# **Update on 41 Bus Service**

#### **New route Northampton - Olney - Bedford**

Britannia announced the operation of a new service between Northampton and Bedford, via Olney and Lavendon on 16 January 2023 and has applied to the Traffic Commissioners for approval for the route. The 350 Northampton to Olney/Milton Keynes Bus Route is referred to on their website. Britannia is consulting local resident groups, elected officials, and others with a view to offering a partial replacement for the newly defunct forty-one service operated by Stagecoach.

Britannia said, "If the consultation and regulatory application are successful, then we envisage starting early March due to the 10-week delay between application for registration and commencement." The route will cover Northampton, Booth Lane, Brafield on the Green, Denton, Yardley Hastings, Olney and Lavendon.

### **Cogenhoe Village Hopper**

The Cogenhoe Village Hopper covers Wollaston, Bozeat, Easton Maudit, Grendon, Whiston, Cogenhoe, Brafield on the Green, Little Houghton, Great Houghton, Northampton on Mondays to Fridays and Wellingborough on Saturday.

The Cogenhoe Village Hopper considered adding a shoppers' service to and from Denton. However, I understand from Deborah Rush, Clerk to Cogenhoe & Whiston Parish Council, that they have not gone any further with changing the Village Hopper route as it seemed pointless if a new operator is setting up.

## Long term outlook for community transport in rural West Northamptonshire

WNC has appointed specialist consultants, SCP, to carry out a review of the way that bus services are currently provided across West Northamptonshire. As part of this process, SCP will bring forward alternative models that would serve our communities better. In doing this work SCP contacted several key stakeholder groups, including bus operators and parish councils. It is anticipated that SCP will present their findings and report to WNC shortly. A report will then be presented to Cabinet. This report will inform our West Northants Transport Strategy that will be developed over the coming period in full consultation with Members and residents. To further support this work, an internal project to review how best community transport can be supported by WNC is underway. This team has yet to report its findings.

## Damaged Grit Bin Bramley Close/Orchard Way, Cogenhoe

I escalated the problem with the damaged Grit Bin on Bramley Close/Orchard Way, Cogenhoe with Fix My Street on 5 January 2023. Cogenhoe Parish Council had raised this matter with me on 4 January 2023. I received an apology for the lack of response and a commitment to investigating why there has been such a delay in responding to this issue. They said that they will ensure that any lessons that can be



learned for the future are implemented, if necessary. The Grit Bin was replaced on 17th January 2023.

#### **Denton Food Larder**

In case you did not know, the Denton Food Larder reopened in the Village Hall, Denton on 9 January 2023. It is now open every Monday at 5.15pm.



I visit it periodically to see how things are progressing. It is always exceptionally well attended.

You can purchase ten items for £5 and then add free bread, fruit, and vegetables to your purchase. They now have a card machine too.

Community larders operate a membership programme that provides access to surplus groceries (store cupboard and refrigerated items, fruit, and vegetables) at heavily discounted rates. The food rescued is saved from landfill and helps stop food waste. The larders are run by volunteers who are committed to getting affordable food

to our communities and are open to everyone. A special thank you to all the volunteers. Why not come along, meet the team, and find out more about how to make your money go further?

### **Cogenhoe Primary School**

I met Mrs Blackwell, Acting Headteacher at the Cogenhoe Primary School on 8 February 2023 to discuss their Road Safety Plans. Their Newsletter of 13 January 2023 included a reference to the fact that WNC had been in touch with the school to make them aware of some potentially unsafe crossing of the road. They have asked parents to be extra vigilant upon pick up and drop off ensuring that



children are not running near the roads and remain accompanied by an adult.

## My Meeting with Aileen Evans, CEO, Grand Union Housing Group (GUHG)

I met with Aileen Evans, CEO and Phil Hardy, Executive Director Operations Grand Union Housing Group on 2 February 2023 to discuss my GUHG case work and agree a number of actions. I was able to resolve most of the issues which were outstanding but there is still further work needed with the following:

### Poor response to residents

I explained that residents were submitting text enquiries via the GUHG customer portal, and they were not gaining a prompt response. I was told that the phone problems were due to the volume of calls. I asked for a statement from GUHG explaining how they intend to improve the situation. In the meantime, I have received a further complaint from a resident of Hackleton, which I have sent to them separately. I now

have a route to escalate all future complaints to Lucy Evans, EA and Phil Hardy, Executive Director of Operations.

### Lodge Road/Close, Little Houghton

I was seeking answers to GUHG in the short and long term. I had already managed to get the leak fixed so that residents in Lodge Road/Lodge Close could use their toilets and take showers, which they had been without for several days. But the longer-term solution still needed to be addressed. GUHG agreed to assist with the overall resolution to the problem. But there is still more work needed to gain a better understanding of GUHG's intentions for their tenants, so that this information can be built into an overall permanent resolution which would include the private owners.

### **Quinton Church Coffee Morning**

I went to the Quinton Church Coffee Morning on Saturday 4 February. Open to all, the monthly first Saturday 10.30-12.00 coffee mornings provide an opportunity to relax and catch up with others from the

local community.

Everyone is always pleased to see a new face and offer a warm

welcome to newcomers! Some of the regulars were not there this week due to illness. I hope that those with Covid get well soon.


## Thank you to John Ford & Anne Henman

# **Proposed Active Travel Improvements around Abington Park, Northampton**

In 2022, Local Authorities were invited to bid for further funds for permanent measures, which promote active travel as part of Tranche 2. The Abington Area Active Travel Scheme, using the design guidance for walking and cycling schemes (Local Transport Note 1/20), seeks to make the following improvements in the Abington area:



- **Abington Park Crescent** a new segregated two-way cycleway and new upgraded crossing at the junction with Park Avenue South
- Bridgewater Drive- a new two-way cycleway towards the school and new road crossings
- Park Avenue South- new cycleways that merge into existing cycling facilities
- **Billing Road / Rushmere Road junction** Significant pedestrian crossing facilities, enabling 'all direction crossing,' along with improved traffic signal technology to better manage all movements.

The scheme will support the development of the Northampton Local Cycling and Walking Infrastructure plan. You are now being invited to have your say. # **New Deadline for Private Hire and Hackney Carriage Licencing Policy Consultation**

Residents, businesses, and professional drivers have been given more time to comment on West Northamptonshire Council's draft Private Hire and Hackney Carriage Licensing Policy. The draft policy sets out the driver, vehicle and operator standards for hackney carriages and private hire vehicles for current licence holders and all new licence applicants.

A consultation launched last month gave people an opportunity to comment on the draft policy. The 26 March



deadline for this consultation has now been extended to Sunday 23 April to allow people more time to fully review it and consider their views. The draft policy focuses on improving standards and public safety and has been shaped by pre- engagement work with local licenced drivers and operators as well as the police. If adopted, it will replace the current policies for the former local authority areas of Daventry, Northampton, and South Northants.

# FINANCE AND TRANSFORMATION

### 2023/24 Balanced Budget Agreed

West Northamptonshire Council has set a balanced budget for the year ahead that will protect essential frontline services whilst addressing significant financial challenges.

At their Full Council meeting in Northampton's Guildhall on Wednesday, 22 February, members approved the final budget proposals, Housing Revenue Account and setting of the Council Tax for 2023/24.



In common with local authorities across the country, the Council is facing severe financial pressures due to factors including the current economic climate, high inflation rates driving up running costs and an increase in demand for services, particularly around supporting children in care and vulnerable adults.

Despite these pressures, the Council has worked hard to balance the books and has set a balanced revenue budget for 2023/24 of £383.5m (excluding grant funded schools spending of £443.7m).

The budget includes a Council Tax increase of 4.99%, well below current inflation rates and in line with the Government's allowance, crucially generating extra funding of around £12m — with 2% of the increase going towards funding adult social care. This represents an average increase on a Band D property of £80.50 a year, the equivalent of £1.55 a week.



The approved budget follows a strong commitment to making services as efficient as possible and reviewing income streams to maintain and protect services, with £32.0m of savings proposals put forward.

It also incorporates a range of additional measures to address people's feedback in the recent budget public consultation, which attracted over 3,000 comments from residents, businesses, partners, and other stakeholders. It has also been subject to continuous review and scrutiny, including consideration by the

cross-party group of members of the Corporate Overview and Scrutiny Committee.

The additional plans include investing an extra £1m in the year ahead towards repairing local roads and changes to car parking proposals include putting in place two hours' free parking on Saturdays and Sundays in Northampton's town centre off street car parks and a set weekend all-day charge of £2.20 for off street car parks, introducing free parking up to 10.30am on Saturdays at Daventry and Brixworth country parks and reducing the proposed maximum daily charge at the two sites by a third to £8.

In addition to this, the Council will be investing up to £215,000 in the year ahead towards bus services. This continues the funding allocated for the current year, while the Council shapes a new bus strategy and considers the most viable options for supporting and delivering the services in the future.

Next year's budget will see our Council invest an additional £30m in capital funding – money earmarked to improve local infrastructure and assets such as land, buildings, and equipment – on a range of projects, some of which will help reduce costs and generate income to support services in future years. Schemes set to move forward in the year ahead will help tackle speeding in rural areas, create new cycleways and footpaths for healthier travel, and improve local roads.






#### **Electoral Boundary Commission Review**

The number of West Northamptonshire councillors and voter areas are set to change at the next local elections in 2025 under The Local Government Boundary Commission for England (LGBCE) proposals. The proposals include reviewing the number of councillor and new boundary areas for West Northamptonshire council wards. Residents are now being encouraged to review the plans and provide their views on recommended voter wards.

On 7 March 2023, the LGBCE launched a public consultation on the proposed map and councillor numbers, following the first stage consultation which took place in autumn 2022 where residents gave their views.



The consultation on the outline areas will run until 15 May and people can get involved by giving their views on the LGBCE's website where they will also find useful guidance and maps of the current wards, via email at reviews@lgbce.org.uk or by post, by writing to the West Northamptonshire Review Officer at: LGBCE, PO Box 133, Blyth, NE24 9FE.

The Commission is the independent body that draws these boundaries. It is reviewing West Northamptonshire to make sure councillors will represent about the same number of electors, and that ward arrangements will help the council work effectively.

The last electoral review in Northamptonshire took place in 2013 and WNC's current electoral arrangements are based on those of the previous county council, with ninety-three councillors serving across thirty-one wards. The Commission has published proposals for changes to West Northamptonshire. It is proposing that there should be thirty-five wards, an increase of four from the current arrangements. There will be seven one-councillor, fifteen two-councillor and thirteen three councillor wards across the council area. The boundaries of all wards should change. Based on the evidence received, the Commission is recommending a council size of seventy-six and not seventy-seven as it originally proposed.

The review is expected to end in late 2023, once the LGBCE has made its recommendations to government and an Order is laid in Parliament to change the legislation and make the new electoral arrangements. # **Changes to Elections Act-Voter ID legislation update**

During December, Legislation mandating voter ID for elections in Great Britain passed through the House of Lords. The voter ID provisions are due to be in place for local elections in England May 2023 and at any UK Parliamentary election held after that date. This week, DLUHC published guidance, which outlines the methodology taken to calculate the value of new burdens funding to be paid to councils to implement the introduction of voter identification and accessibility. The guidance sets out the modelling approach



undertaken to estimate these costs and allocate funding to councils to support the delivery of elections and electoral registration activities. Read more about Voter ID legislation and DLUHC new burdens guidance.

### **Food Crime**

When you think of illegal activity, food crime might not be the first thing that comes to mind, but it is something that it is happening in West Northamptonshire



and across the country. Food crime is where food and drink are sold illegally and is often unsafe or is not what is claims to be. It can range from isolated acts of dishonesty by an individual to organised illegal activities planned by criminal networks and is estimated to cost £1.17 billion a year in the UK. There are many types of food crime, which the most common being:

- Theft dishonestly obtaining food, drink, or feed products to profit from their use or sale
- Illegal processing slaughtering or preparing meat and related products in unapproved premises or using unauthorised techniques
- Waste diversion illegally diverting food, drink or feed meant for disposal, back into the supply chain
- Adulteration including a foreign substance which is not on the product's label to lower costs or fake a higher quality
- Substitution replacing a food or ingredient with another substance that is similar but inferior
- Misrepresentation marketing or labelling a product to wrongly portray its quality, safety, origin, or freshness
- Fraud making, using, or possessing false documents with the intent to sell or market a fraudulent or substandard product.

Unfortunately, there are individuals and businesses that continue to exploit consumers by illegally selling and distributing counterfeit items which can be seriously harmful to consumers, food businesses and the wider food industry.

What to look out for:

- Food or drink, which is significantly cheaper than you would expect it to be.
- Concerns at a food business where they could be extending durability date, using poorer quality products, or making false claims.
- You see food being delivered to a business in a non-business vehicle.

- be specific enough to allow the response to be made within the Appropriate Limit



and Fees Regulations (18 hours of officer time to collate, prepare and respond)

However, you do not have to mention the Act or direct your request to a designated member of staff.

West Northamptonshire Council is a newly established organisation combining the former district and borough councils of Daventry, Northampton, and South Northamptonshire along with Northamptonshire County Council. If your request relates to a prior district/borough council service, please indicate which geographic area your request relates to help us respond promptly with the relevant information. If you do not state either the geographic area or West Northamptonshire as a whole, we reserve the right to clarify this before proceeding with your enquiry.

You should then expect to receive a response within twenty working days. Only in exceptional circumstances will a request be extended and then only because of complex exemption considerations or deliberations.

# **RURAL SERVICES NETWORK (RSN)**

# **Rural Cost of Living Survey**

People living in rural areas are being urged to complete a survey on the cost of living. The Rural Services Network (RSN), in partnership with the Citizens Advice Rural Issues Group, has launched the Rural Cost of Living Household Survey to understand more about rural household budgets during what is a very difficult time for many.

Independent research commissioned by the RSN, in the summer last year showed rural areas are suffering more acutely from the cost-of-living crisis compared to urban areas. To lend more weight to the argument for more funding for rural areas the RSN is calling on as many rural residents as possible to complete a Rural Cost of Living Household Survey. Research has shown that those living in rural areas face extra costs and the RSN wants to explore the impacts for households. People are encouraged to help by completing the survey by the closing date of 31 March.



The results will help the RSN engage more effectively with Government Departments, MPs, and other policy makers. Please help spread the word by forwarding the survey link to contacts, networks, family, and friends living in rural areas.

### **Kovia Consulting Rural Cost of Living Report**

You may like to read the report, Rural cost of living, by Kovia Consulting for the Rural Services Network (RSN), which discovered people living in rural areas are facing 'dual energy vulnerability' with costs of energy, house prices and transport higher than in other areas. RSN also discovered that rural households spend 50% more on transport a week due to a reliance on a car. Bus routes in these areas are continuing to be cut, with a 27% decrease in bus services across England in the past 10 years. In summary, RSN concluded that rural areas are facing a triple burden of higher heating and transport costs, while also earning a lower income. https://rsnonline.org.uk/images/publications/rural-cost-of-living.pdf


RSN are asking Government to overcome policy silos and develop an integrated approach that recognises the multiple forms of disadvantage rural areas face.

### **WNC Response to Government Consultation on reforms to NPPF**

At the Planning Policy Meeting on 28 February, the WNC response to the Government's consultation document on proposed reforms to national planning policy except for the response to question 5, was agreed as set out in Appendix A of the report (link below). ### **Building Control Services Back in House**

Plans are progressing to bring Building Control services back in-house to West Northants Council from the



beginning of April 2023. Back in 2015 the Building Control function for the former Daventry District Council was transferred to a shared service with Warwick and Rugby Councils.

Following the establishment of West Northants Council, work has been ongoing with partners, officers, and stakeholders to bring this service back in house to enable a single consistent service to be provided across the whole of West Northants. These plans are well underway and are now nearing completion, as part of this work we are in the process of recruiting for new colleagues to join the new structure.

WNC will continue to keep you updated on the progress of this work and I anticipate that contact details and more information about the service will be shared during February.

# **DLUHC Proposes an Increase in Planning Fees**

The Department for Levelling Up, Housing & Communities (DLUHC) proposed an increase in planning application fees in a new consultation, which opened on 28 February 2023. The consultation said the government has received "consistent feedback from all sectors" that due to an "absence of adequate resources and capability" the planning application service is not "consistently performing at the level it should." According to the consultation, the "funding



shortfall for the planning application service is estimated to be in the region of £225m annually".

DLUHC is therefore proposing to raise planning application fees by 35% for major applications and 25% for all other applications. This means that for non-major developments the fee will go up from £462 to £578 and for major developments it will go up from £462 to £624. The proposed rise in fees would apply to all applicants unless they are eligible for existing exemptions.

DLUHC said that the new fees will "provide additional income for local planning authorities" whilst not "unfairly introducing disproportionately high fee increases" for households and small businesses. However,

DLUHC's consultation points out that "money is not enough" and has proposed to "provide local planning authorities with additional resources to deliver an effective planning service."

The consultation highlights how DLUHC plans to work with representatives of the planning sector "to design and deliver a programme of support for building planning capacity and capability within local planning authorities" to seek how capacity and capability within the system might be increased.

DLUHC said it is "only prepared to introduce fee increases if planning performance also improves." The consultation therefore proposes "a new approach to how the performance of local planning authorities is measured across a broader set of quantitative and qualitative measures." The department hopes this will "provide greater transparency" for users of the planning system and "earlier and more targeted support to local planning authorities where needed."

The consultation opened on 28 February and will run for eight weeks until 25 April.

# HOUSING

### **West Northamptonshire Housing Strategy**

Councillors have approved a fresh strategy for improving housing for residents across West Northamptonshire whilst tackling issues including homelessness and the cost-of-living crisis.

At a meeting on Friday, 23 September members of the Council's Cabinet agreed to progress proposals for the new strategy which sets out plans for the next three years and supports the Council's vision.

The strategy focuses on four themes which plan to tackle several key issues including a need for more affordable housing, reducing homelessness, addressing cost of living increases and recognising a need for more housing to meet the needs of our growing aging population.

The themes set out in the strategy are:

Deliver homes people need and can afford

Improve the quality, standard and safety of homes and housing services

Support residents to live healthy, safe, independent, and active lives

Support thriving and sustainable communities

The strategy was developed following a public consultation earlier this year involving local community members, voluntary and charitable organisations, and wider stakeholders, with overall feedback presenting strong support for the themes and priorities.

West Northamptonshire is a growing area, with a population of 425,700 (2021 Census) residents, it is anticipated that the population will grow by 7% up to 2030, and the number of households is set to grow by 12% by 2030.

Within that, the population aged 65 year and over is expected to grow by 9%, which represents 76% of total population growth.

# **ENVIRONMENT**

### **Reduce Unwanted Contamination in Recycling Bins**

People are being encouraged to make sure they put the right stuff in their recycling bins in a bid to reduce contamination and significant disposal costs.

The overwhelming majority of residents do a fantastic job sorting their recycling and putting it in the correct bin for collection by our waste and recycling crews.

However not everyone gets it right, and the addition of plastic bags, hard plastics such as children's toys and washing up bowls, duvets, cushions, and even car tyres in some recycling bins risks contaminating entire lorry loads of recycling. This can lead to whole loads being rejected and set for disposal, costing on average more than £30,000 each month.

Waste and recycling crews have been carrying out work to reduce unwanted contamination in some parts of Northampton

recently, placing advisory stickers on recycling bins that contain the wrong items.

The stickers feature a list of what can and cannot be recycled, so that residents can remove any non-recyclable items ahead of their next scheduled collection day.

Future exercises to tackle recycling contamination in partnership with our contractors will be supported in advance by planned communications activities, to ensure wider awareness.

Bin hangers reminding people of what to put in their recycling bin will be distributed to all households in Northampton in the coming weeks, and social media messaging will remind people of the dos and don'ts of recycling.

There are several typical contaminates that people tend to put in their bins in the mistaken belief that they can be recycled, and our messaging will aim to clarify and bust some of the myths around those.

#### These include:

- Soft plastics such as carrier bags, packets, and wrappers these should be put in your general waste bin. Shopping bags can be recycled at some supermarkets
- Nappies these must be put in your general waste bin
- Kitchen roll and tissues these should be placed in your general waste bin
- Drinking glasses and glass cookware such as Pyrex dishes these cannot go into your recycling bin, but could be recycled at your local Household Waste Recycling Centre
- Hard plastics such as toys and washing up bowls these cannot go into your recycling bin, but could be recycled at your local Household Waste Recycling Centre
- Batteries and electrical items these can cause bin fires so should never be disposed of in general rubbish. Instead, leave them on top of the waste bin (in Daventry) or on top of the recycling bin (Northampton and South Northants) for recycling.
- Disposable vapes cannot be recycled or disposed of at home but can be taken to a Household Waste Recycling Centre or the shop where you bought them.



We are also reminding people of good practice around recycling, such as rinsing out food/drink containers before recycling, and placing items loose in recycling bins, rather than in bags.

# **Garden Waste Collections 2023/24**

Residents across West Northamptonshire can now sign up to receive optional, chargeable garden waste collections from April 2023. The annual subscription charge for the fortnightly service from April

2023 to the end of March 2024 is £55 per bin and people can subscribe via the link on our website: <a href="https://www.westnorthants.gov.uk/bin.../garden-waste">https://www.westnorthants.gov.uk/bin.../garden-waste</a>

Residents also now have the option to sign up for an annual Direct Debit to save having to remember to renew every year. Residents who are unable to access the internet can subscribe to the service by phoning the council on 0300 126 7000. Once households are signed up to the



service, they will receive their new 2023/24 garden waste permit which should be put on their garden waste bin. Any bins that have not subscribed will not be emptied after 4 April. The communications plan to promote the service will begin in earnest next week, with a press release, articles in council newsletters, and a social media campaign set to get underway on Tuesday. Existing subscribers will be sent emails inviting them to re-subscribe and those not on emails will receive a letter.

Many people value the garden waste service, however there are others who do not need these collections. By ensuring that it is an optional service, only those who wish to receive the service must pay for it, making it as fair for residents as possible. People who do not wish to sign up to the service have the option of composting their garden waste at home, either in a traditional compost heap or by purchasing a compost bin by visiting <a href="www.getcomposting.com">www.getcomposting.com</a> and typing in their postcode to see offers available. People can also recycle garden waste for free at any of our household waste recycling centres. Hackleton and Grange Park. WNC are testing its emerging LAP model with two Pioneer sites, DSN4 and another site in Northampton. We will be exploring how we might work in a collaborative way to improve outcomes for our patients and constituents within our local area.

#### **New SEND facilities**

More children in Northamptonshire with special educational needs will be able to access specialist support with the official opening of a new SEND department. The new provision, called Caterpillar Pod, is based at Castle Academy in Northampton, and offers ten places for pupils in Key Stage 1 with social and communication difficulties. It was officially opened on 24 February 2023. It follows the recent opening of a SEND department at Hardingstone Academy, called Butterfly Meadow, for Key Stage 2 learners. Both schools are part of East Midlands Academy



Trust. The additional provision of the Caterpillar Pod brings to children with special educational needs and disabilities a new, high-quality education department that is best suited to their needs. These additional places further contribute to WNC's commitment to increasing SEND provision, helping to ensure every child and young person has access to the best available education and learning.

### **Cost of living boost for students**



Students in need are to benefit from additional financial support designed to ease cost of living pressures and help them to meet everyday costs whilst they are completing their studies. In recognition of the challenges some students have faced due to the global rise in inflation, the government has announced that it will provide an

additional £15 million in hardship funding this financial year so that universities can provide extra support to students that need it most.

It builds on the £261 million that the government has already provided to the Office for Students (OfS) for the 2022/23 academic year which universities can draw upon to boost their own hardship funds. Universities are responsible for ensuring students who need help get the support they need, including through their own hardship funds, or through bursaries and scholarships.

# **New Children's Social Care Implementation Strategy**

The Government has announced plans to transform children's social care, putting families at the heart of \_\_\_\_\_\_ reform.



Backed by £200 million over the next two years, a new, ambitious, and wide-ranging Children's Social Care Implementation Strategy will transform the current care system to focus on more early support for families, reducing the need for crisis response at a later stage.

# Secondary School Places Allocated on 1 March 2023

A total of 4,784 secondary school places were allocated to pupils across West Northamptonshire on 1 March 2023. 94.2 per cent (4,506) of applications were allocated a place at one of their preferred schools, with 77 per cent of applicants (3,686 children) receiving a place at their first preference. A further 13.1 per cent (626) of pupils received a place at their second preference school, and 4.1 per cent (194) of pupils at their third preference school.

The opening of the new Northampton School in September 2023 will provide an additional 210 places for



Year 7 students. The permanent site for the new school will be in Thorpeville, Moulton.

As it is the first year of opening for Northampton School, the school will issue separate offers for its 210 available places to successful applicants — this is not included in the preference data above.

Families who applied for their secondary school place online and within the deadline received an e-mail offer on 1 March 2023 and were able to check their offer on the council's online Admissions Portal.

Any parent has the right to appeal (through the independent appeals process) against refusal of a place at any school for which they have applied.

The next round of secondary school place allocations (for late applicants) will take place in April / May. Primary school allocations will be announced on 17 April.

## The Foyle Foundation Small Grants Scheme

I thought you might like to hear about a small grants scheme available through the Foyle Foundation. I get requests from community interest groups and Parish Councils for grant funding, and I was pleased to hear last week that one of the suggestions that I had made had resulted in a Community Group acquiring £5k grant funding from a little-known company-The Foyle Foundation.



The Foyle Foundation was formed to implement the terms of the will of the late Christina Foyle. She was the daughter of William Foyle who, with his brother, founded the family-owned bookshop Foyles in Charing Cross Road, London, which she continued to manage after her father's death.

This Small Grants Scheme is designed to support charities registered and operating in the United Kingdom, especially those working at grass roots and local community level, in any field, across a wide range of activities.

Online applications can be accepted from charities that have an annual turnover of less than £150,000 per annum. Larger or national charities will normally not be considered under this scheme.

The focus will be to make one-year grants only to cover core costs or essential equipment, to enable ongoing service provision, homeworking, or delivery of online digital services to charities that can show financial stability.

The priority will be to support local charities still active in their communities which are currently delivering services to the young, vulnerable, elderly, disadvantaged or the general community either directly or through online support if possible.

### **Apprenticeship Scheme West Northamptonshire Council**


An apprenticeship scheme at West Northamptonshire Council is going from strength to strength with eighty active learners now employed by the authority. This week the UK is celebrating National Apprenticeship Week, offering a chance for businesses and apprentices across the country to shine a light on the positive impact that apprenticeships make to individuals, businesses, and the wider economy. The theme for National Apprenticeship Week 2023 is 'skills for life'; reflecting on how apprenticeships can help individuals to develop the skills and knowledge required for a rewarding career, and businesses to develop a talented workforce that is equipped with future-ready skills.

With no upper age limit to becoming an apprentice, an increasing number of people aged over sixteen are favouring apprenticeships as a way of studying towards a formal qualification while working.

# **Community Transport Grants – Motability**

Through this new grant programme Motability aim to help charities and organisations to make an immediate impact for disabled people, by awarding funding to develop, expand and improve community transport options. The programme is focussed on:





- Funding to increase the number of vehicles available in the community to help organisations support disabled people.
- Funding local, regional, or national initiatives to increase awareness of community transport and influence its inclusion in transport strategy and policy.
- Funding to schemes, programmes and initiatives that already exist, and who provide best practice solutions, but need further support to remain operational or scale up the service they can provide to help more disabled people.

Charities and organisations working in the community transport sector can apply for grants from £100,000 to £4 million at any point over the next three years until March 2025.

# **The Animal Paradise Trail**



Endangered animals will be on show in Northampton this Easter as the town centre hosts an amazing trail of sculptures made entirely from toy bricks. The Animal Paradise trail, presented and built by BRICKLIVE, has been commissioned by Northampton Town Centre Business Improvement District (BID) and will feature fifteen models of creatures including snow leopards, tigers, penguins, and orangutans.

Families can get involved in the trail, which runs from April 1-16, by downloading the LoyalFree app onto

their smartphone and scanning QR codes at each host venue to find out more about the model creature on display in the window. All those who complete the trail via the app will be entered into a prize draw to win one of two £100 vouchers. Model builders are busy preparing the displays, with the animals ranging in length from 50cm to a 252cm tall Bengal tiger made from 118,160 bricks.

### **Defra Support for Farmers**

Defra is increasing money available for farmers and land managers. On the 5th of January, Minister Mark Spencer gave a speech at the Oxford Farming Conference, in which he announced more support for farmers through these difficult times of rising costs.

They are updating payment rates for both Countryside Stewardship revenue options and capital items from the start of this year. They are also introducing a new Sustainable Farming Incentive (SFI) 'management payment.' In addition to the money already available through the SFI, Defra will pay up to £1,000 for the first fifty hectares to cover the costs farmers incur when entering the scheme.

The payment will benefit all farmers in SFI, but it will particularly benefit smaller farms (up to fifty hectares).



Defra state this is one of a series of actions announced to help farmers face challenges in the current economic climate, including increasing the frequency of Basic Payment Scheme payments to help with cashflow and introducing measures to help limit fertiliser costs this year.

Defra suggests there is something available for everyone in their package of environmental land management schemes and one-off grants. They would encourage all farmers to look closely at what is on offer so they can find what works best for their business. The Farmers' union, NFU, welcomed the rise but warned it could be "too little too late" in the economic climate.

The announcement comes amid rises in the cost of food production, with farmers hit particularly hard by increases in the cost of animal feed, fertilizers and fuel. The increased rates under ELMS will come from existing money, reallocated from the previous direct payment subsidies given to farmers under the EU scheme. NFU vice president David Exwood said it was still unclear what work farmers - who will be losing direct payments - would be paid for under ELMS.

### **Oxford Cambridge Arc**

Proposals for a locally led partnership for the Oxford to Cambridge Arc have been given the green light by



the government. The partnership, which includes Northamptonshire, will champion the region as a world leader of innovation and business, acting to achieve environmentally sustainable and inclusive growth. It will strengthen the cross-boundary collaboration among its partners to focus on tackling the issues that matter to the people who live and work in the region.

The partnership's initial programme is to:

- Develop a set of propositions to attract international investment and profile the region on a global stage
- Continue the work underway to embed shared environment principles

West Northants is right at the heart of the arc and WNC wants to make sure it plays a key role in helping shape its future, to the benefit of its residents.

Following the official commitment from government, the Partnership will begin active recruitment of an independent Chair. In the interim, a Shadow Board has been set up to oversee the Partnership's programme and agree governance and funding.

#### Small Grant Programme (older people) – Charles Hayward Foundation

Grants are available up to £7,000 for charities with an annual income of less than £350,000.

This programme wishes to fund early intervention preventative and programmes being delivered at the community level, which allow older people to stay in their own homes and remain independent. They are particularly interested in seeking out programmes, which show some creativity in improving the quality of life of older people.



- Programmes aiming to alleviate isolation and depression in older people, including informal day care or social, physical, and recreational activities.
- Programmes, which give practical help, assistance and support for older people living in their own homes.
- Programmes addressing the emotional and practical needs of older carers.

Programmes designed to meet the specific needs of people with dementia. Applications will be considered every three months (March, June, September, and December).

# Specialist Grant Programme – Lloyds Bank **Foundation**

The focus of this programme is to support small, local, specialist charities with an income of £25,000-£500,000 where the Foundation's three-year unrestricted £75,000 grant and support to develop,



can make the greatest impact. They will support charities that understand the complexity of the issues people face and are best placed to make a genuine difference to people's lives.

Grants are available up to £75,000 and three years. The deadline for applications is 3 March 2023.

# A New Energy Discount Scheme for **Businesses, Charities, and the Public Sector**

A new energy scheme for businesses, charities, and the public sector has been confirmed, ahead of the current scheme ending in March. The new scheme will mean all eligible UK businesses and other nondomestic energy users will receive a discount on high energy bills until 31 March 2024. This will help



businesses locked into contracts signed before recent substantial falls in the wholesale price manage their costs and provide others with reassurance against the risk of prices rising again.

The new scheme therefore strikes a balance between supporting businesses over the next 12 months and limiting taxpayer's exposure to volatile energy markets, with a cap set at £5.5 billion. This provides long term certainty for businesses and reflects how the scale of the challenge has changed since September last year.

#### Platinum Jubilee Village Halls Fund

Platinum Jubilee Village Halls Fund – Department for Environment, Food & Rural Affairs and Action with Communities in Rural England (ACRE)

The aim of the Platinum Jubilee Village Halls Fund is to support the modernisation and improvement of village halls, so that they are fit for purpose and can provide activities which seek to achieve one or more of







the following outcomes for their communities:

- 1) Improved health and/or wellbeing and/or reduction in rural loneliness,
- 2) Positive impact on the local environment, contributes towards net zero,
- 3) Support for the local rural economy,
- 4) Promotion of community cohesion.

Grants are for capital improvements only, where projects aim to either upgrade, extend or improve facilities, or where capital items need to be purchased. They cannot be used for maintenance, repair, or renewal work.

The initial deadline for Stage 1 applications was 20 January 2023. The fund will re-open for Stage 1 applications in mid-February 2023. Demand on the fund will then dictate how long ACRE is able to accept Stage 1 applications.

# **Review of West Northamptonshire Bus Services**

WNC has appointed specialist consultants, SCP, to carry out a review of the way that bus services are currently provided across West Northamptonshire. As part of this process, SCP will bring forward





alternative models that would serve our communities

better. In doing this work SCP will be contacting several key stakeholder groups, including bus operators and parish councils. It is



anticipated that SCP will present their findings and report to WNC in January 2023. A report will then be presented to Cabinet. This report

will inform our West Northants Transport Strategy that will be developed over the coming period in full consultation with Members and residents. To further support this work, an internal project has begun by officers to review how best community transport can be supported by WNC in the future with the current financial pressures. The project team will be engaging with stakeholders to discuss the current situation and potential solutions.

### Department of Transport £2 Single Fare extended for three months

The BBC report the £2 cap on bus fares in England has been extended for three months following warnings that hundreds of services could be cut if it ended. The cap applies to more than 130 bus operators outside London. It had been due to expire on 31 March but has been extended until the end of June.



Bus operators have been struggling to maintain service levels in the face of rising costs and passenger numbers not recovering to pre-pandemic levels. The cap was introduced partly as a cost-of-living measure but is also meant to encourage people back on to buses.

Up to 15% of services could have been scrapped without further funding, the Confederation of Passenger Transport, which represents bus and coach firms, said earlier this month.

### **Flare Report**

A new, free smartphone app – Flare Report – has been launched to help women and girls feel and be safer on the streets of Northamptonshire. Women and girls can use it to report incidents and behaviour that are

inappropriate and make them feel unsafe, such as catcalling, comments or touching, street harassment or other threatening behaviour.

Flare is not for reporting crimes in progress that need an immediate response, but Police will check reports every day to make sure that nothing that needs an urgent response has been submitted. Northamptonshire Police, Fire and Crime Commissioner Stephen Mold has brought the app to the county and hopes that reports made on Flare will help to build a clearer picture of where incidents are happening and give women the confidence to report things that might otherwise go unreported.
