### **NEWS REPORT SEPTEMBER 2023**

### **Monthly Highlights**

This month I requested copies of the signing plans for the changes to the A428 to introduce a 40mph speed limit order on Bedford Road, Northampton and a 50mph speed limit on A428 Northampton Road, through Great Houghton, Little Houghton, Brafield on the Green, Denton, Castle Ashby and Yardley Hastings. The existing 30 mph stretches through Brafield on the Green and Yardley Hastings remain unchanged. WNC has now received all the information required and has sent the instruction for the works to be carried out, which should be within three months.

On Sunday 4th June 2023, Stagecoach East made changes to the 41 service within the Cambridgeshire and Bedfordshire network. So, let's see what we can do to market and encourage an increase in bus patronage along this route so that we can secure it for the foreseeable future.

With regards to the flooding at Blacksmiths Way, Hartwell, WNC has completed and assessed all the surveys. They concluded that to prevent future flooding on Blacksmiths Way they need to undertake the following works.

- Ditch clearance on Ashton Road (south of Oakleaf)
- Replace 12 metres of drain in access to Oakleaf. This will be reinforced with concrete to prevent any future damage by tree roots.
- Near 17 Ashton Road undertake works to replace/repair section of drain.

In addition to the above we will also be replacing a section of drain on Blacksmiths Way which does not have a top. Hartwell Parish Council to fund replacement gully top on Blacksmiths Way.

Our next site meeting has been scheduled for 26<sup>th</sup> September at 2pm. In the meantime, I will provide an update every two weeks with progress.

I attended several events across the ward of Hackleton and Grange Park this month. Please read more about my activities in my Monthly Report.

People are being invited to have their say on proposals for how social housing will be allocated across West Northamptonshire from spring next year. West Northamptonshire Council (WNC) is currently seeking views on its new draft Housing Allocation Scheme, which is due to be implemented on 1 April 2024.

Join Citizens Advice for their next cost-of-living briefing on September 14th, 12-1pm. Guest speakers will be announced shortly. See my Monthly Report for further details.

In the Local Government Boundary Commission final report published on 1 August 2023, the Commission has concluded that West Northants residents should be represented in the future by 76 councillors as the figure best facilitated a new warding pattern throughout the district. It means that from 2025 WNC councillors would be elected on a four-year term across 35 wards instead of the current 31 – comprising 13 three-councillor wards, 15 two-councillor wards, and seven single-councillor wards. More than 100 projects around the country are being supported by the Community Ownership fund. Successful projects that DLUHC have funded to date include assets such as:

- community centres
- sporting and leisure facilities

- pubs
- cultural buildings
- heritage buildings

Community Tree Planting Grants are available, and applications can be submitted from June onwards with a final deadline of 15 December 2023. See my Monthly Report.

Daventry Country Park, Abington Park, Bradlaugh Fields and Delapre Park have all retained their Green Flag Awards - nationally recognised as the benchmark for the management of recreational outdoor spaces.

The Summer Reading Challenge launches on Saturday, 8 July. Participants will be rewarded with a medal and certificate upon completing the challenge. The Library Service has also partnered with local leisure centres to provide a voucher entitling children to a free swim or badminton, table tennis or squash court hire, depending on location. The Challenge runs until Saturday, 9 September and aims to increase children's reading engagement and confidence. Further information around the Summer Reading Challenge and library events and services can be found on the libraries' webpage.

Join us for the CarKraft Young Driver Event on 17th Sept 2023. This exciting event at the Silverstone Circuit is perfect for young drivers looking to enhance their skills behind the wheel. Get ready for a half-day of fun and educational activities to improve your driving abilities.

A new town centre manager has been appointed to improve the appeal of Brackley and Towcester Town Centres to visitors and businesses. Samantha Hosking took up her post a month ago and will be the key point of contact working for West Northamptonshire Council in partnership with Brackley Town Council and Towcester Town Council.

Volunteer bus drivers are sought to support with this year's Heritage Open Days, which take place from 8 to 17 September. Drivers will need a category D PCV (passenger carrying vehicle) licence. We are also looking for volunteer bus conductors, who do not need a licence. Training will be provided for both drivers and conductors. 

### Signing Plans for the changes to the A428

I have received copies of the signing plans for the changes to the A428 to introduce a 40mph speed limit

#### **41 Bus Service**

Rural areas, like urban areas, should be able to plan bus networks that meet people's needs. If bus patronage is going to grow, the bus user must be prioritised, whether that bus user is in a city or in the countryside. Rural local authorities need to have a range of options for creating high quality networks in their areas including the pooling of existing bus funding. Rural areas have of different transport services commissioned and run by different bodies: social services, education, health, youth service etc. If these were brought together, better rural transport services could be provided with no



extra cost. I want to see more authorities co-ordinating their transport services and funding, and the Government promoting this through local area agreements.

In the meantime, we need to market and encourage an increase in bus patronage along this route so that we can secure it for the foreseeable future.

### Legal position on any predetermination discussions about Planning Applications

As the Chairman of the South Northamptonshire Local Area Planning Committee, I may be involved in the decision making for any subsequent planning application. Section 25 of the Localism Act 2011 provides that a decision maker is not to be taken to have had, or appeared to have had, a closed mind when making the decision just because:

- (a) the decision maker had previously done anything that directly or indirectly indicated what view the decision maker took, or would or might take, in relation to a matter; and
- (b) the matter was relevant to the decision.

This provision does not change the law on bias and pre-determination which means that Committee Members must still take planning decisions with an open mind and having considered all relevant material planning considerations. The safest course is for Committee Members to avoid making public statements (including expressing views in emails) as to their support for or opposition to any application which would indicate they had made up their minds before the formal consideration of the application at the meeting. If a Committee Member has made such a statement, they must be satisfied that they can still consider the application with an open mind and are prepared to consider any new matters or any new arguments in favour of or against the proposed development until the decision is made otherwise, they should not take part in any decision on the application in question.

On the grounds of the above, it would not be appropriate for me to attend Parish Council or Community events which seek to take a decision regarding the outcome of a planning application as I must keep an open mind on this matter so as not to preclude me from participating in any future planning decisions.

### **Afghan Resettlement Scheme**

On 28 April, Minister Mercer announced to Parliament the government's determination to close all Afghan Bridging hotels across the UK by the end of the summer. The reasons were two-fold; that it was not right for people to be living in hotels long term, and it is not affordable for the British public to continue to fund this situation. The Afghan nationals in the two hotels in West Northamptonshire currently house just over 140 people, and over 380 have been moved on into settled accommodation since the establishment of the hotels in September 2021. The current position following notice being served on Bedford Road for 26 August (effective from 25 August) and at Flore for 31 August is:



The Flore hotel is currently accommodating 45 people, comprising 14 discrete households including some single men, and the Bedford Road hotel is accommodating 96 people, comprising 31 discrete households, again including some single men. We currently have several moves in the pipeline which range from families who have agreed accommodation offers and are just awaiting transport to be confirmed, to people part way through conversations with agents and landlords.

As it stands, if all these moves are realised, we are currently looking at around 60 individuals who will not have a viable

option at the end of the process and who the Council will need to assess a homelessness duty for. This is a fast-moving, dynamic situation and will change over the coming days and weeks. We are working extremely hard to ensure that we can find options for everyone at both hotels.

As a Council, our pledge is to resettle and support 10 households and we are committed to fulfil that pledge, whilst also utilising alternative means to resettle people through partnership working with NNC and other local authorities and utilising LAHF funding and additional homelessness funding. Additionally, DWP are assisting with homeless 'Duty to Refer' referrals to relevant local authorities, however the majority of cases will fall to WNC to provide housing and assistance, and for single men, an additional, bespoke option will be explored following the model of the Homes for Ukraine sponsorship scheme.

### **CONSULTATIONS**

### **Community Governance Review Consultation**

The LGBCE (Local Government Boundary Commission for England) have been conducting a ward boundary review for our Council. These changes will impact on some parish councils whose boundaries no longer align with our new wards. If a parish boundary is not aligned with a council ward, this may result in the

need for parish wards to be created to enable the election to be conducted in areas which fall outside the council ward boundary. This can lead to additional expenses for parishes in the conduct of elections.

To meet this challenge WNC are preparing a Community Governance Review, allowing Town and Parish Councils an opportunity to put forward proposals to change their boundaries and the number of members. It also allows for the possibility of merging with an adjacent parish or parish meeting. Responding to the review WNC have written to parish councils recently, to ask them to express their interest in being part of that review, and we are being asked to encourage parishes in their wards to respond to us.



In order to be a part of the Community Governance Review, parish and town councils needed to email their views to electoralservices@westnorthants.gov.uk no later than 18 August.

WNC were particularly asking parishes to consider the following:

- Are there any parish meetings which should be incorporated into a parish council?
- Should any parish councils be merged with another parish council or parish meeting?
- Are any changes required to the existing boundaries of a parish to better reflect local communities?
   (This may be particularly relevant in areas where there has been housing development for instance.)
- Are there any parish councils that should be renamed to better reflect the communities they represent?
- Please note that the following is not within the scope of this review:
- The ward boundaries of West Northamptonshire Council
- Parliamentary boundaries
- The conduct or membership of individual parish councils or meetings.

WNC started preparing for the Community Governance Review as soon as our Council's new ward boundaries were confirmed, and we will draw up proposed terms of reference for the review.

The proposed timetable was as follows:

- 1 August 2023: Final decision of the Boundary Review
- 18 August 2023: Deadline for requests from Parishes for Community Governance Reviews
- 28 September 2023: Report to Council to commence Community Governance Review
- 28 September 2024: The Community Governance Review must be completed by this date.

The review will require West Northamptonshire Council to draw up proposals as to how the boundaries will be redrawn and then to carry out public consultation in relation to those proposals before a final decision is reached. A formal decision is made by full Council to amend the boundaries.

- By December 2024: Polling Station Review for new wards and parishes
- January May 2025: 2025 Election delivery underway

### **Housing Allocations Consultation**

People are being invited to have their say on proposals for how social housing will be allocated across West Northamptonshire from spring next year. West Northamptonshire Council (WNC) is currently seeking views on its new draft Housing Allocation Scheme, which is due to be implemented on 1 April 2024.



There are currently three housing allocation schemes that operate in West Northamptonshire covering the Daventry, South Northants, and Northampton areas. The existing policies operate in different ways to each other, therefore introducing a West Northamptonshire Housing Allocation Scheme will harmonise these differences making it fairer, clearer and more consistent across the West Northamptonshire area.

Residents, tenants and housing associations are among those being encouraged to give their feedback on these

proposals as part of a 10-week consultation starting today (19 July) and running until midnight on Tuesday, 26 September.

All responses will be considered and will help to shape a final version of the scheme to then be considered by West Northamptonshire Council's Cabinet this autumn. To view the draft proposals and complete the online questionnaire, visit the WNC Consultation Hub.

The new draft housing allocation scheme sets out proposals for who would be eligible and could apply for social housing across the whole of West Northamptonshire, along with how the Council processes applications, assesses and manages people's housing needs, and determines who should have priority for social housing.

Plans include expanding the Choice Based Lettings approach to allocating social housing across the whole West Northants area, which is already used in the Daventry and Northampton areas. Choice based lettings allows applicants to register an interest in properties they prefer that are suitable for their household size.

The consultation will last 10 weeks and closes on 26 September 2023. Residents can take part in the following ways:

### **Parks & Open Spaces Consultation**

West Northants Council manages over 160 parks and open spaces. ### **Consultation to close Emporium Way**

This week we launched a consultation to seek the views of local residents and businesses around a proposal to temporarily close Emporium Way in Northampton, which has become a hotspot for anti-social



behaviour and crime. The walkway is located off Northampton Market square and provides shortcuts to Sheep Street and the nearby Mayorhold and Newlands carparks, however, in recent months it has attracted illicit activities including loitering, urination, muggings, fighting and drug dealing. To tackle these behaviours, we are proposing to make a Public Spaces Protection Order to close the public highway temporarily. If the Order is approved, the walkway will be closed 24 hours a day, seven days a week until the market square. redevelopment is complete in Summer 2024, with

redevelopment is complete in Summer 2024, with access to all adjoining areas available via alternative routes. Please encourage residents and local

#### **Local Government Boundary Commission Review Issued**

76 at the next local elections in 2025 under the final recommendations of a review by the Local Government Boundary Commission for England (LGBCE).



West Northamptonshire Council (WNC) welcomed the outcome of the wide-ranging review, which is the first to take place for 10 years and sees changes to all electoral ward boundaries across the area. The LGBCE's conclusion must now be scrutinised and approved by Parliament before legally coming into force for the next WNC elections in 2025.

In their final report, the Commission has concluded that West Northants residents should be represented in the future by 76

councillors as the figure best facilitated a new warding pattern throughout the district. It means that from 2025 WNC councillors would be elected on a four-year term across 35 wards instead of the current 31 – comprising 13 three-councillor wards, 15 two-councillor wards, and seven single-councillor wards.

In response to residents' feedback during the review, other recommended changes by the Commission include creating two single councillor wards in the north of Daventry and merging two of draft recommendation wards in the south-west of the area to form a two-councillor Middleton Cheney ward.

The last electoral review in Northamptonshire took place in 2013 and WNC's current electoral arrangements are based on those of the previous county council, with 93 councillors serving across 31 wards.

LGBCE launched the review in summer 2022, holding its review in two stages with public consultation, firstly looking at the number of councillors, and then looking at how many wards, and the names of those wards.

### **Community Ownership Fund**

Local assets such as sports clubs, music venues and historical buildings will be able to apply for government funding as part of the third round of the Community Ownership Fund, with £150 million worth of allocations available. Thanks to changes to the way the funding is delivered, it is now easier for the control



of prized assets to be seized back by community groups.

This will help with the strengthening and levelling up of local communities, whilst also restoring optimism, hope and pride. The changes see the requirements for match-funding being reduced, making the process of acquiring assets without private funding easier.

Parish Councils are also now able to apply for the fund, with it previously only being available to charities and community groups.

More than 100 projects around the country are being supported by the fund.

Successful projects that DLUHC have funded to date include assets such as:

- community centres
- sporting and leisure facilities
- pubs
- cultural buildings
- heritage buildings

#### **Community Organisations Cost of Living Fund**

The national Lottery Community Fund is for organisations that support people and communities under severe pressure because of the increased cost of living. The main priority is to fund organisations supporting low-income households and individuals. You can apply for between £10,000 and £75,000.



To apply your organisation must already run critical services around at least one of the following:

- 1) food and emergency supplies like food and baby banks
- 2) provision of hot meals, clothes or toiletries
- 3) emergency shelter like night shelters or other accommodation for people experiencing homelessness.
- 4) safe spaces like domestic abuse services and youth services

- 5) warmth like warm rooms and spaces
- 6) financial and housing advice like giving people advice because of the increased cost of living. Your organisation must also be facing both increased demand for these critical services and increased costs of delivering these critical services. The deadline for applications is 16 October 2023 and funding must be spent by 31 March 2024.

### **Community Tree Planting Grants**

The UK Community Tree Planting Programme aims to support community projects that will:



- Conserve, restore and protect indigenous trees and woodlands, forests, habitats and associated biodiversity.
- Support community engagement in tree planting to promote reforestation and to increase awareness of the importance of trees and forests to environmental and human well-being.
- Encourage social cohesion and inclusion.

To be eligible, your organisation must be community-based e.g. a school, community group or non-governmental organisation. There are two tiers of funding available:

- Small scale: A maximum of £1,000 is available for projects of up to 1 year in duration. This could be small community woodland, orchards, hedging projects, etc.
- Larger scale: Projects to range from 1000 10,000 trees, with a maximum price equivalent to £1.50/tree (inclusive of tree protection). Most suitable for community woodland or hedging projects.

Applications can be submitted from June onwards with a final deadline of 15 December 2023.

#### **Action Plan to tackle issues with HMOs**

A new action plan to tackle issues around Houses of Multiple Occupancy (HMOs) is set to be discussed by West Northamptonshire Council's (WNC) Cabinet next week. At the meeting planned for Tuesday, 11 July, Cabinet Members will consider the latest report which details proposals to crack down on unregulated and poorly managed HMOs, tighten planning controls and improve private renting for tenants. The report provides a summary of work achieved by the HMO Member working group, which includes Members drawn from cross party membership, and makes recommendations for the implementation of an action plan for the Council to progress.

The working group also heard from local residents and Ward Councillors in seeking to understand the perceived community impact of HMOs, along with representatives from the Northampton Student Landlord Network.

Proposals put forward in the plan include:

- a. Tackling litter and rubbish generated by HMOs
- b. Monitoring general maintenance of properties
- c. Reviewing room sizes and amenities for tenants
- d. Maintaining a register of licensed HMOs
- e. Enforcement action against unlicensed HMOs
- f. Reviewing the Housing regulatory regime; including the Council's Additional HMO and Selective Licensing Regimes
- g. Ensuring information is available to local communities via the Council website.

Other proposals in the plan include improving parking in neighbourhoods with HMOs by investigating vehicle ownership and use across licensed HMO properties and single-family dwellings of a comparable size and reviewing rules and best practice relating to HMOs and their impact on local communities in other areas of the country.

The report also recommends that planning decisions are made in line with the Article 4 Direction policy - planning legislation which allows the Council to remove permitted development rights in order to protect



local amenities or the wellbeing of an area, and to ensure that this information is available to residents, communities, property owners, and developers.

### New Scheme to cut Fuel Poverty & Tackle Climate Change

West Northamptonshire Council is pushing ahead with a plan to harness renewable and wasted heat to tackle fuel poverty and make the Northampton area a more sustainable place.

It has announced work on a Sustainable Heat Network Feasibility Study to explore the possibility of a

district heating system that can deliver lower-cost, low-carbon heat to homes and businesses. District heating collects warmth from a variety of sources and uses a distribution system of insulated pipes to carry it from a central source to multiple buildings. This can significantly reduce heating costs and carbon emissions compared with traditional heating solutions which use electricity or burn fossil and other fuels. To bring this vision to life, West Northamptonshire Council has secured £112k



from round 12 of the Government's Heat Network Delivery Unit (HNDU) funding. The project will also be match-funded by contributions of £20k from Northamptonshire Partnership Homes and £40k from the council's Public Health team.

The project, built on work originally launched by Department for Business, Energy & Industrial Strategy (BEIS, now Department for Energy Security & Net Zero) in 2019, will now focus on the Northampton and Rothersthorpe Village area.

Its aims are to:

- Update the previous BEIS report, to include data from those located within the wider boundary now covered by the project.
- Investigate opportunities for multiple energy centres, including recoverable heat from different sources such as commercial activities, sewer network heat recovery, and water bodies.
- Produce a detailed feasibility study highlighting sustainable heat generation options, costs for providing the heat network, carbon savings, potential energy costs for users, operating costs, income and commercial viability,
- Identify where West Northamptonshire and other social housing stock can be supplied with heat from the network.

Sustainable engineering firm, Ramboll, will work on the project with infrastructure consultancy, AECOM, following a competitive bidding process.

Upon completion, the feasibility study will provide critical data on sustainable heat sources, technical and financial costs, and potential funding opportunities. The council aims to apply for funding from HNDU round 13 to cover the detailed project development phase based on the study's findings.

### **Support Needed for Energy Bill Amendment**

Can you help? Article provided by OFTEC, one of RSN Rural Services Partnership members.



You may be aware that the government has proposed to phase out the installation of appliances that burn oil, LPG or coal in homes and non-domestic premises off the gas grid. For homes, the end date is 2026, some nine years earlier than similar proposals for homes that use gas. In most cases, the owners will be expected to install a heat pump instead. While the need to reduce emissions is important, there is concern that the proposals treat rural dwellers unfairly, exposing them to much higher installation costs and significant disruption, while denying them the opportunity to

choose a low carbon heating system that best suits their needs.

If you currently use oil heating, you may be interested to know that the Cornish MP, George Eustice, has tabled amendments to the Government's Energy Bill. The amendments would enable a renewable liquid fuel called HVO to be made available at an affordable price for heating use. It costs around £500 to convert existing oil heating systems to use HVO, compared to the significant costs of between £10,000 and £30,000 to install a heat pump in off grid homes, and HVO delivers a carbon reduction of around 88% compared to fossil fuel heating oils. Conversion can be achieved in little more than hour, making it exactly the kind of friction free solution that rural households and businesses need.

To be successful, the amendment needs to be supported by as many MPs as possible. You can help by asking your MP to support the amendment.

### **Tackling Environmental Crime**

Fly-tipping and environmental crime has a significant negative impact on our streets and countryside. West Northamptonshire Council (WNC) is committed to reducing fly-tipping through the fly-tipping charter,



which is backed by a robust enforcement policy to discourage and prosecute offenders.

The Charter includes a detailed plan of action, demonstrating the steps that are being taken to tackle the issue, including targeted patrols, the use of CCTV, and working with residents, businesses, and town and parish councils to avoid fly-tipping and gather intelligence to prosecute.

Through the cleaner communities campaign, WNC seeks to highlight the negative impact of environmental crime and demonstrate the work of officers to tackle this and remove fly-tipping on

the land where we have a responsibility to do so. Through investigation and working with the public to share information WNC will hold people to account and prosecute offenders.

It also sets out how the Council will communicate with businesses, landlords and householders to ensure they are clear on their responsibilities towards managing their waste responsibly.





West Northamptonshire Council (WNC) has awarded £10,000 in funding to Trilogy Active to continue to deliver free sports and wellbeing activities in Northampton.

The activities run across different areas of Northampton and include walks to improve mental health and



The Northampton Wellbeing Walks Programme, which is part of the nationally recognised Ramblers Wellbeing Walks programme, aims to provide everyone with access to a short group walk within easy reach of where they live. The walks allow people of all abilities to meet and connect with new people in their area whilst getting more active and will be delivered 14 times per week across 12 locations in Northampton, all free of charge.

The Street Sports initiative is a doorstep sport programme

which aims to engage young people in underserved communities and use sport as a diversionary activity to create positive change by providing free to access sport and exercise activities.



The programme includes 10 weekly sessions for people aged 8 to 18 years and will take place across the Thorplands, Kings Heath, Blackthorn and Bellinge areas of Northampton.

#### **Cervical Cancer Screening**

Cervical Cancer Screening is available to those between the ages of 25 to 64 and is crucial in helping to pick up signs of cervical cancer at an early stage. Cervical cancer is when abnormal cells in the lining of the cervix grow in an uncontrolled way and in time, form a growth also known as a tumour. If not caught early, cancer cells gradually grow into the surrounding tissues and may spread to other areas of the body which can be life threatening.

With West Northamptonshire data showing a percentage of people not taking up a cervical screening test, the local Public Health team is advising residents between the age of 25 to 64, who are eligible for cervical cancer screening to make sure they attend their screening appointment and remain up to date with their screening.

Dr Annapurna Sen, Consultant in Health Protection for West Northamptonshire Council says:

"Across West Northamptonshire 30% of the eligible population between age 25-64 did not have their cervical screening test, especially younger women. This may risk many of these people with cervical cancer go undetected, which may spread due to delay in

Attend your screening appointment as it is reliable at picking up cancers or abnormalities that could lead to cancer and will do more good than harm to you. If you have missed your last appointment or are putting it off, take the time to call your GP and discuss booking an appointment."

### **STACK to transform Market Walk Shopping Centre**

WNC is delighted to be working with a leisure developer, STACK, to transform the vacant Market Walk shopping centre in Northampton town centre. STACK completed the acquisition of the Market Walk site earlier this month and will now bring forward an exciting regeneration and development project to transform the site to offer an innovative food hall and leisure space. Previously known as Peacock Place, Market Walk occupies a prominent spot at the heart of the town centre, next to the historic Market Square. However, the site has stood empty for a number of years. To complete the project, WNC will provide up to £4.2 million investment through the Towns Fund, coupled with private investment of £8 million from STACK. Once finished, the space will host a series of independent street food traders, a variety of bars and a



dedicated space for interactive games, all focussed on communal seating and a main stage for live music performances and entertainment. This type of leisure concept is already successful in other cities in Newcastle and Sunderland. STACK Newcastle welcomed over 3 million visitors in the first three years and STACK Seaburn attracts over 70,000 visitors per month. The repurposing of the shopping centre will enhance the town's vibrancy and vitality, supporting both the daytime and night-time economy and complementing the ongoing transformation of the historic Market Square and public realm of Abington Street and Fish Street. Following the successful acquisition, the developers will now take the first steps to seek the relevant planning and licensing permissions to bring this project forward for delivery over the coming months.

### **WNC Acquires Vacant Job Centre Site**

The former Job Centre located in Wood Street Northampton has been purchased by West Northamptonshire Council (WNC) as part of the ongoing redevelopment of 35 – 45 Abington Street.

The site is in the heart of the town centre, set just behind Abington Street and the Grosvenor Centre. Having sat vacant for more than a decade the site has fallen into disrepair. WNC has bought the building to



ensure that this site benefits from restoration and provides high-quality homes and services for the local community.

The £475,000 freehold price plus costs, was funded through the Towns Fund, which is allocated by Government to enable WNC to transform Northampton Town Centre. WNC has been able to acquire this site to form part of the wider regeneration of the former BHS and M&S stores.

The Towns Fund is part of the Government's plan for Levelling Up the UK economy and the Council has

secured £24.9 million to invest into transforming Northampton's Town Centre. The completion coincides with the Expression for Interests as WNC seeks a development partner for the site. The sites will undergo extensive redevelopment to deliver modern leisure or retail spaces to the ground floor with new homes for residents above.

Through the densification of the site, it will bring forward new homes and flexible leisure space and which will lead to increased footfall into the centre to support the existing retail offer within the wider town.

The next phase of the project on the former BHS property will see the large central building, measuring approximately 60,000 sq. ft undergo a full internal strip out and the removal of any asbestos containing materials. This will ensure the building is safe and secure and enable the Council to bring forward the exciting regeneration project at the earliest opportunity.

These works form part of the Northampton Town Centre Masterplan (2019). The wider regeneration of Northampton Town Centre includes the Market Square redevelopment which will see this area become a cultural hub for the town centre, and public realm works in Abington Street and Fish Street which will see the area transformed with new paving, improved seating, lighting and landscaping, and public art installations.

#### **New Town Centre Manager for Brackley and Towcester**

A new town centre manager has been appointed to improve the appeal of Brackley and Towcester Town Centres to visitors and businesses. Samantha Hosking took up her post a month ago and will be the key



point of contact working for West Northamptonshire Council in partnership with Brackley Town Council and Towcester Town Council. Her new role, which is funded as part of a Section 106 financial contribution made by local developers as part of their planning permission, will include establishing relationships with local businesses, the community and voluntary organisations. Samantha, who lives locally, will coordinate and lead on a programme of

improvements and innovations to revitalise the much-loved towns whilst promoting the areas for investment and business growth and helping the local economy thrive.

### A New Energy Discount Scheme for Businesses, Charities, and the Public Sector

A new energy scheme for businesses, charities, and the public sector has been confirmed, ahead of the current scheme ending in March. The new scheme will mean all eligible UK businesses and other non-domestic energy users will receive a discount on high energy bills until 31 March 2024. This will help businesses locked into contracts signed before recent substantial falls in the wholesale price manage their



costs and provide others with reassurance against the risk of prices rising again.

The new scheme therefore strikes a balance between supporting businesses over the next 12 months and limiting taxpayer's exposure to volatile energy markets, with a cap set at £5.5 billion. This provides long term certainty for businesses and reflects how the scale of the challenge has changed since September last year.

### Funding to improve quality of life of older people

Grants are available up to £7,000 for charities with an annual income of less than £350,000.

This programme wishes to fund preventative and early intervention programmes being delivered at the community level which allow older people to stay in their own homes and remain independent. They are particularly interested in seeking out programmes which show some creativity in improving the quality of life of older people.

Programmes aiming to alleviate isolation and depression in older people, including informal day care or social, physical and recreational activities.

Programmes which give practical help, assistance and support for older people living in their own homes.

Programmes addressing the emotional and practical needs of older carers.

Programmes designed to meet the specific needs of people with dementia.

Applications will be considered every three months (March, June, September and December).

### **Surface Dressing for Eight Key Roads**

The condition of eight key roads across West Northamptonshire is set to be improved over the coming weeks. More than 100,000 square metres of highway are to undergo surface dressing between now and mid-September.

Following the completion of the works, road users should adhere to the temporary road signage, and are required



to take extra care. Loose chips are laid onto a layer of bitumen to seal the road surface and provide better grip for vehicles. There is a short-term heightened risk of skidding from the loose chippings so motorists must reduce their speed when travelling on the treated sections of road network.

The roads earmarked for the 2023 surface dressing programme up to 13 September include:

- A428 Bedford Road East, Yardley Hastings
- A5076 Redhouse Road, Northampton
- A45 London Road, Weedon
- A5199 Welford Road, Thornby
- A508 Harborough Road, Maidwell
- Scaldwell Road/Lamport Road, Old
- B4031 Croughton
- Station Road, Aynho

### **Bus Fare Cap Extended until end of October**

On Wednesday, as part of the Help for Households support, the government announced that they are extending discounted bus travel. To help people with cost-of-living pressures and save on everyday travel costs, the government will continue to cap single bus fares at £2 outside London until the end of October



2023 and then at £2.50 until 30 November 2024 —when the government will review their effectiveness and future bus fares.

The government has published a list of bus companies and bus routes included in the £2 bus fare cap scheme. The government also announced £160 million will be provided to local transport authorities to improve fares, services and infrastructure while £140 million will go to operators to help protect essential services across England.

### **Northamptonshire Strategic Transport Model**

West and North Northamptonshire Councils have teamed up to start work on a new version of the Northamptonshire Strategic Transport Model. The model uses a computer simulation to anticipate traffic flows and is used to inform strategic planning where new developments or major roads are proposed.

It was last rebuilt in 2015, since when technology has moved on significantly, meaning a full overhaul is needed to ensure the data it produces is as accurate as possible. Each council will contribute £78,000 toward the project from fees charged to developers using the model, alongside £400,000 previously allocated by the former Northamptonshire County Council.

Hosting, maintenance and operation fees could take costs to a total of around £2m over the life of the contract. West Northamptonshire Council will



lead on procurement of the model rebuild. As part of the process, each council will have its own version of the new model, but it will be managed through a continued relationship with the consultancy building it. The new model will have a 2023 base year, informed by verified traffic count data, and the process is expected to be complete by autumn 2024, with a contract anticipated to run until 2031.

West Northants Council's response to the consultation welcomes that staff will still be available to assist with ticket purchases, customer service and passenger assistance, but warns that there should be no reduction in staffed hours compared to the current ticket office hours. The response also highlights that the needs of the partially sighted and those with mobility issues must be fully taken into account. In addition, simplification of the fares structure as well as an improvement in both the quality and number of ticket machines are required before the changes can be made.

### **Expansion of E-Scooter Service**

People in Northampton have taken 3 million trips on e-scooters across the town over the last three years. And now, Voi, together with West Northamptonshire Council (WNC), has announced the expansion of its e-scooter service to the north and south of Northampton to include Moulton and Collingtree.

Since the e-scooter trial was launched in September 2020, public hire e-scooters have become an important addition to transport in the town, with just over 63,000 people in Northampton now signed up to Voi, using them to commute to work and education.

E-scooters are a much greener way to travel and since their introduction in Northampton have replaced over 1.4 million car journeys, clocking up over 4.3 million miles and reducing CO2 emissions in the town by an estimated 667 tonnes.

Safety is Voi's top priority with the company hosting a number



of online safety webinars which cover all aspects of safely riding a Voi e-scooter or e-bike, from wearing a helmet, to the correct position in the road and how to park without causing an obstruction for pedestrians. Remaining webinars for 2023 have been scheduled for Tuesday 12 September at 5.30pm and 6.45pm, Thursday 19 October at 12pm and 1.15pm, Tuesday 14 November at 5.30pm and 6.45pm and Thursday 7 December at 12pm and 1.15pm. Anyone completing a safety webinar will receive 30 free minutes for use on either a Voi e-scooter or e-bike and a helmet. Riders must be 18 or over and have a provisional or full driving licence. ### **Serious Violence Consultation**

The feedback provided will help the Northamptonshire Serious Violence Alliance deepen its understanding of the views and experiences of residents across the county and identify the kinds of serious violence that happen in the county, enabling authorities to put effective schemes in place which focus on preventing crime and intervening early to reduce the chances of someone committing or becoming a victim of crime. The specified authorities responsible for the Northamptonshire Serious Violence Alliance include Local Government Authorities, Criminal Justice, Health and Social Care, Police, and Fire and Rescue authorities. Serious violence can affect anyone, and the impact can be life changing - whether you are a victim, their friend or family member, or a witness. That is why we are strongly encouraging anyone who has been affected by serious violence in the last 12 months to share their experience in this survey and help us to improve the safety and wellbeing of people in our communities.

The Northamptonshire Serious Violence Alliance will also be going out to communities and involving various stakeholders to collect information in addition to this survey. Dates and times of these public events for people to attend to find out more will be released at a later date.
